<u>Course Description:</u> Topics include a brief review of introductory algebra, variation, elementary theory of equations, functions (including exponential and logarithmic) inequalities, systems of equations, and other related topics.

Prerequisites: Two years of high school algebra and one year of high school geometry. Credit 3.

<u>Course Objectives:</u> This course is designed for those students who need preparation beyond two years of high school geometry before taking the calculus sequence. In this course the student is expected to obtain an understanding of:

- The principles involved in the algebra of real and complex numbers
- The concept of a function and how to use algebraic and geometric properties to study properties of functions
- How to use functions and algebraic principles to model and solve real-world problems

Required Textbook: College Algebra, 8th edition, by Aufmann

<u>Required Supplies:</u> You must have a calculator that can evaluate roots, powers, exponentials, and logarithms (a scientific calculator will do this)

EVALUATION PROCEDURES:

- **♦ Homework (15%):** Homework will be assigned as sections are completed in lecture. Homework due dates will have one class day between assigning and turning in (i.e. if assigned on Monday → due Friday)
- ❖ Quizzes (15%): Quizzes will be given at least once a week, unless otherwise noted in the last 10-15 minutes of class. It is an incentive to keep up the concepts gone over in class. Occasionally, the quizzes will instead be group work done in class. The will be NO make-up quizzes given (so come to class each day), but your lowest quiz grade is dropped at the end of the semester.

- Unit Exams (50% total): There will be three unit exams during the semester.
- ❖ Final Exam (20%): The final exam will be comprehensive. It is NOT optional. If it is beneficial, your final exam grade can replace your lowest unit exam grade.
- **❖ Make-up Policy:** You <u>cannot</u> make-up an exam, homework assignment or quiz. Missing assignments are given zero points.

Attendance: You should attend all classes and are responsible for all notes, announcements, assignments, quizzes, and exams. If you must miss class, notify me via email as soon as possible as to why you were not in class or will not be attending class. Student athletes who anticipate missing a class, exam, or assignment due to a University sponsored athletic event must provide appropriate documentation and notification **PRIOR** to the absence.

Electronic Devices: The use by students of any device that is performing the functions of a telephone, text messages, or pager during class-time is prohibited. The visible presence of such a device during the test period will result in a zero for the test. Use of these devices during a test is considered de facto evidence of cheating. Recording devices, such as cameras, audio recorders, or video recorders may not be used without prior approval of the instructor.

Academic Dishonesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, collusion and the abuse of resource materials.

Classroom Rules of Conduct: Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins. Students are prohibited from using tobacco products in class, making offensive remarks,

reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

Visitors in the Classroom: Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.

Student Absences on Religious Holy Days Policy Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
