**Course Description and Objectives:** Provide the student with a basic understanding of the hazards, regulations, and options for precautions in an agricultural setting. The purpose of this course is to provide a sphere of knowledge for the student desiring a position related to agricultural safety.

**Assignments:** Students will be provided an assignment(s) weekly. All assignments will be due by 8am the following Monday after assigned. In most cases, the student will be required to submit assignments via email or through the class website. Because ALL assignments are posted on the first day of class, there will be no late work accepted without prior notification of extenuating circumstances.

**Exams:** Regular exams will be required. They will be available beginning at 8am on a Monday and will be open until 5pm the following Friday. Once started, each exam will be open for **One Hour**. The comprehensive final exam will be open for **2 Hours** at your convenience, beginning at 8am on 4 Dec, and will be available until Friday 8 December at 5pm. Again, no make-up exams will be allowed without reviewed extenuating circumstances.

**Rules of Conduct** (for class meetings and as applicable to the online environment)
