Course Description:

This course consists of the design and development of a dwelling space (floor plan), sections, details, and specifications for a one floor residence. Before the completion of the plans and specifications for the residence, students, in learning the tools in Revit[®], will produce plans, sections, details and specifications, etc. for a two story residence with a basement (tutorial).

Homework:

Assignments will be given during the semester to assess the student's understanding of the various concepts that are covered under a particular topic. All assignments are to be submitted on time. There are no exceptions except for reasons beyond the control of the student, such as health problems.

Exams:

A total of 5 quizzes will be issued in the semester. The student will produce many drawings leading to the completion of the residential building as discussed in the text. That will allow students the necessary practice that is needed to work on a final project on their own. This completed work will be accounted as the student's mid-term exam grade.

Project:

There will be a project assigned for this course. The main purpose of the project is for the student to employ the various concepts learned during the semester into the design process and problem solving. Each student will design their own residential building based on the specifications that will be issued to them. This final work will be accounted as the student's final exam grade. The project will consists of a completed floor plan, section(s), elevations, 3D interior / exterior presentation drawings, and construction document set.

Assignment Problems:

These problems will be taken and the end of the chapters in the textbook (Architectural Drafting and Design-7th Edition). However, problems may not be limited to the end of chapter questions but may be a variation of a particular problem or other problems assigned by the instructor or a combination of both. They are due at the beginning of the next class.

Course Material and Topics to be covered in the Course

This course consists of the development of a set of plans and specifications for a two story residence with a basement (tutorial) and the design of a one floor residence (designed by the student). An overview of the various building elements and components will be discussed, together with building materials and construction techniques. Content of course will include but not limited to floor plans and design, dimensioning, exterior elevations, sections, construction methods, details, and door, window, and room schedules.

Course Format

The course will make use of lectures, demonstration, in class problem solving, and student drawing exercises. The students will be required to complete a series of drawings based on the course content with the use of the Autodesk® Revit® Architecture.

Class Participation:

Class participation is strongly encouraged in this class.

Personal Conduct in Classrooms and Laboratories:
