# **COURSE DESCRIPTION**

This course will consist of drafting theory, applications, techniques and requirements necessary for civil engineers. Topics include survey drafting, map drafting, topos, site plans, sub-division plats, profile drawings, and other related topics.

# **COURSE GOALS**

On successful completion of ETCM 3371, the students will be able to:

- Describe a variety of civil engineering components and systems
- Understand a working knowledge of civil drawings and documents
- Show the beginning level of competence in computer aided civil drafting
- Understand a limited scope of Geographic Information System (GIS)

This course will cover the theory, techniques and requirements for civil drafting which will add to the skill sets of construction management. The course components include as follows.
