1 Course Description (Catalog)

A study of the complex relationship between the business sector and the public sector in the United States and in the global marketplace. Topics will include the regulation of business in its various formats and the promotion of business nationally and internationally.

- 2. gained a basic understanding of industrial organization, the branch of economics focusing in understanding businesses and their relationships with the government especially through regulations
- 3. gained a basic understanding of game theory
- 4. gained a basic understanding of the industries covered, especially in relation to economic theories
- 5. developed, analyzed, and critically evaluated points of view in business-government relationships

Homework assignments and reading assignments are **due in the BEGINNING of class on the scheduled due days** (listed in the tentative class schedule attached to the end of this syllabus). Assignments are graded for both completion and correctness. Among the 20 total potential points, 5 are given based on completion (turning in the homework on time) and the rest are awarded based on correctness. No late homework will be accepted.

There will be two mid-term exams plus the final. All exams are closed-book and mandatory. The second mid-term exam will only cover materials since the first mid-term, while the final exam will be comprehensive. Students will be given the entire class period (80 minutes) to complete a mid-term exam. A missed exam will be recorded as a zero. If you know ahead of time that you will not be able to take a mid-term exam at the scheduled time, come to me and discuss the conflict *at least 24 hours ahead of the scheduled exam period*. An arrangement may or may not be made for you to take the exam early. However, under no circumstances will you be allowed to take an exam after the scheduled time.

All students must take the final exam. There are no make-up final exams, unless otherwise permitted and approved according to SHSU policy. Students must take the final exam at the officially scheduled time. The final exam period is 120 minutes.

Exam scores will be posted on SHSU Online once graded.

You will need to write a report on a particular industry (see list below) and present your findings. Reports are due on Thursday, April 12, 2018. Only electronic submission will be accepted. Your file should be in either Portable Document Format (.pdf) or MS Word document format (.doc or .docx).

You can act solo or form groups of two to finish the report and the presentation. To encourage the formation of groups, students who are on their own will not be able to choose an industry; instead, I will assign you an industry. For groups, choice of industry is granted in a "first come first serve" manner. Note that students in the same group will receive the same score for the written report but scores from presentation may be different. Requirements and grading rubrics will be made available at a later time.

7.3 Attendance and Movements Into and Out of Class

The instructor reserves the right to record attendance for each class meeting. According to university policy, "regular and punctual class attendance is expected of each student at Sam Houston State University." See your undergraduate catalog for more details.

While the student is in class, he/she is expected to be awake and paying attention. Students should not study for another class while in this class. Students should not come and go from the classroom during the lecture, unless in extreme situations. Moving into and out of class interrupts the flow of class material, distracting both the students and the professor. 7.4 Student Absences on Religious Holy Days Policy

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
