Course Overview

Almost half the world-over three billion people- live on less than \$2.50 a day. 22,000 children die each day due to poverty. About one-third of children in developing countries are either stunted or wasted. Some 1.1 billion people in developing countries have inadequate access to water, and 2.6 billion lack basic sanitation. Nearly a billion people entered the 21st century unable to read a book or sign their names. Very gloomy picture!

The goal of this course is to expose students to the development challenges faced by economies worldwide especially in sub-Saharan Africa and South Asian countries with some reference to disadvantaged communities in the US. The focus is to better understand the economic lives of poor, causes of poverty and poor health in developing countries and explore the solutions to these challenges. The course will approach these issues from microeconomics perspective and will analyze economic behavior at micro level i.e. individual and household. The course will also discuss program evaluation techniques to understand which policy works the best to eradicate poverty.
