## **COURSE DESCRIPTION:**

This course is designed to provide students a forum for presentation of their graduate project and to provide an opportunity for faculty to present seminars relative to contemporary issues in agriculture. The project is an agreement between student and his/her committee. Course cannot be repeated. Pre-Requisites: None. Credit: 1.

## **COURSE COMPETENCIES AND EVALUATION METHODS:**

Upon completion of the course, students will be able to:

- 1) Summarize effective career skills, including résumés or curriculum vitaes, interview techniques and search skills.
- 2) Explain the purpose of preparing a research synopsis.
- 3) Describe the basic objectives of presenting research.
- 4) Demonstrate effective research presentation skills.
- 5) Create a research presentation.
- 6) Examine contemporary issues in the agricultural industry.

## **CLASS FORMAT:**

This courses meets one day per week for 50 minutes. Therefore, there will be a certain intensity in each class session. Information will be disseminated through lecture, but with a conversational tone. Class participation/discussion is expected. Individual assignments and presentations are embedded in the course to foster a greater understanding of scientific research. The course will require significant outside reading and research-related preparation. Assignments will require written and/or computer composition, oral presentation and adherence to your disciplinary citation style.

#### ATTENDANCE POLICY:

Presence- the fact or condition of being present (<a href="www.merriam-webster.com">www.merriam-webster.com</a>). I make a commitment to you that on M 5:00-5:50 pm this semester, unless I am away on SHSU approved travel, ill or dealing with a family emergency, when I walk into PIRK 340, I will be present in mind, body and spirit out of respect for you. I ask the same of you. As a graduate student, you should understand by this point that returns are generated from investment. I expect us to hold each other accountable out of respect for each other's investment in this class.

Students are expected to attend all class meetings. Classes will begin promptly at 5:00 pm. As a seminar class with periodic guest lecturers, attendance is crucial. Each absence, late arrival and/or early departure will affect the student's Attendance, Participation and Professionalism grade. Three (3) absences will result in the loss of a letter grade. A fourth (4) absence will result in the loss of two letter grades. If an emergency or other justifiable reason prevents a student from attending class, the instructor should be notified as soon as possible. However, an absence will still be assessed regardless of the reason.
