4. Course Description: Topics may include sets, counting principles, probability, logic, linear algebra, linear programming, number systems, mathematics of finance, geometry, and calculus.

Prerequisites: Passing score on the Math TSI Assessment or equivalent. (Two years of high school algebra and high school geometry.) The class will be primarily lecture-oriented.

- 5. Course Objectives: You will learn to analyze, logically address, and solve problems.
- 6. **Required Textbook:** *Mathematics, A Practical Odyssey* by Johnson and Mowry, 8e. We will cover all or parts of three to five chapters.
- 7. **Required Supplies:** A scientific calculator with permutation and combination keys will be needed for the course. I have and will be using the TI-84 plus.
- 8. **Attendance Policy:** You are expected to attend every class *and to arrive on time*. If class must be missed, you are expected to get the notes and homework assignment from a classmate.
- 9. Assignments:
  - (a) **Homework:** Homework will be assigned almost every class period and *collected periodically*. At least once a week, I will give a quiz based upon the homework, required reading, and lectures. It is your responsibility to ask questions about homework problems which you were not able to complete or did not understand.
  - (b) **Quizzes:** The quizzes will be based on the homework assignments, required reading, and lectures. Each quiz will be given during the first 10-15 minutes of class, and extra time will not be allowed, if you are late to class. *There are no make-up quizzes*, but (at least) your lowest quiz score for the semester will be dropped.
- 10. **Exams:** There will be three exams during the semester and then a final exam. The exams are scheduled to occur on or around:

Any changes to this schedule will be announced in class.

There are no make-up exams. If you miss an exam because of an emergency, then contact me immediately. With my approval, the percentage on the final exam can replace the missed exam.

The final exam is Wednesday, May 9, 2017 from 9:30 - 11:30 a.m. It will be comprehensive, unless otherwise notified.

- 12. Academic Dishonesty: All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. - 13. Classroom Rules of Conduct: Students will refrain from behavior in the classroom that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Cellular telephones and pagers must be turned off before class begins and cannot even be visible during an exam. The visible presence of such a device during the test period will result in a zero for that test. Students are prohibited from using tobacco products in class, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.
- 14. Visitors in the Classroom: Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.
- 15. **Religious Holidays:** Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.
  - University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable time frame in which the missed assignments and/or examinations are to be completed.
