- 7. **Course Description:** This course is designed to meet the objectives of Component area 2 of the core curriculum for non-business and non-science related majors. Topics may include sets, counting principles, probability, and logic. Applications are emphasized. Prerequisites: Two years of high school algebra and high school geometry. Credits-3.
- 8. **Required Textbook:** Johnson/Mowry. <u>Mathematics-APractical Odyssey</u>. 8<sup>th</sup> edition. We will be using Webassign for our online homework. The price is \$100, but this includes the e-book. You do not need to purchase the book unless you want a hard copy

Other requirements: A scientific calculator that includes permutation and combination keys is required. I have and will be using the TI-84 Plus.

- 9. **Attendance Policy:** Students are expected to attend every class. If class must be missed, it is the student's responsibility to get the notes and assignments for that class meeting. A sign up sheet will be passed around at the beginning of each class period so that the instructor may monitor attendance.
- 10. **Assignments:** Quizzes will be given on Fridays. Make-up quizzes will not be allowed, and a zero will be given for any missed quiz. Several quizzes will be dropped at the end of the semester, with the number of dropped quizzes to be determined at a later date. Homework assignments will be given daily. The homework can be found at <a href="www.webassign.net">www.webassign.net</a>. The code for the homework is shsu 0146 8588. The cost is \$100, and includes the e-book. **THERE WILL BE**

**NO EXTRA CREDIT GIVEN DURING THE SEMESTER**. It is important that you keep up with the homework, be on time for quizzes, and be present for all tests.

- 11. **Exams:** There will be four exams during the semester. At least one week's notice will be given prior to the exam. There will also be a cumulative final exam at the end of the semester during the regularly scheduled exam time for this course. There will be no make-ups for missed exams other than for SHSU approved reasons. The lowest test grade will be dropped.
- 12. **Grading Plan:** The final grade will be determined as follow:

- 13. **Academic Dishonesty:** All students are expected to engage in all academic pursuits in a manner that is above reproach. Cellular telephones and pagers must be turned off and put away before class begins. Text messaging will not be tolerated and any student doing so will be asked to leave. Students are prohibited from eating in class, using tobacco products, making offensive remarks, reading newspapers, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who

are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy.

- 15. **Visitors in the Classroom:** Unannounced visitors to class must present a current, official SHSU identification card to be permitted in the classroom. They must not present a disruption to the class by their attendance. If the visitor is not a registered student, it is at the instructor's discretion whether or not the visitor will be allowed to remain in the classroom.
