#### COURSE DESCRIPTION

Catalog: This course explores the use of the figure as subject matter in art. Observational skills are practiced and refined and personal expression is emphasized. A variety of media are explored. The use of the figure in contemporary art is studied. Prerequisite: ARTS 1313, ARTS 1314, ARTS 1315, and ARTS 1317.

Using the human body as subject matter, students will produce a body of work, which culminates in a 7 piece series. Personal vision and expression will mature, through drawing, while emphasizing the conceptual. Content and intention will be challenged/developed/expected/refined and alternative processes encouraged. The thematic final series originates from a student-determined precept. The personal interpretation of the use of the unclothed body will be the focus of discussion and critique. Exercises and research will be conducted. For the sake of understanding, the words assignment, work, piece, and solution all mean the same in class and in this document.

Prerequisite: Arts 1313, 1314, 1315, 1317.

#### **COURSE OBJECTIVES**

# Goals:

- 1. Learn to clarify expression by refining an idea. Critically reviewing work, analyzing the visual content. What is efficient and effective in the use of props -those objects used in composition and their arrangement that support the expression of the conceptual.
- 2. Learn to clarify expression by using mark making, or craftsmanship of the artwork to facilitate understanding of the work. Which materials or marks contribute to effective expression.

Learn the process of producing artwork in series. This isn't doing a number of pieces from one idea, but it's a maturation process that requires reevaluation after each piece is completed in the series.

#### ATTENDANCE POLICY

Attendance is required. Three absences only are allowed for the semester. If you know you'll be missing let me know. If a specific in-class exercise would be missed, I will give you instruction for completing the missed work. (Absences may require producing make-up drawings, either in the department's sponsored model sessions or in the students own model arrangements. A single page of multiple gestures and a single page of a more developed drawing would satisfy the requirement.) A 4<sup>th</sup> absence will lower the in-class drawing grade one full grade. A 5<sup>th</sup> absence will result in an F for the course.

In a typical class period in Life II you will begin and complete multiple drawings. And, there are many days when I lecture or we critique work at the very beginning of class. Therefore, missing any portion of class, by arriving late or leaving early is an attendance issue, because of what is missed. I will count every instance of arriving late or leaving early as a 1/2 absence.

Every day, you must have all the necessary materials, charcoal, conte, graphite, ink, marker, etc. and best paper, etc. You may borrow materials on that day and it will be counted as present. If you don't have the tools to work, it will be recorded as an absence each time it happens.

#### **GRADING POLICY**

#### Assignments:

There are 3 types of assignments, outside of class, in-class and final series. The daily drawing is done in-class, most of the time from the model, sometimes exploring an idea about the figure in context. There will be outside of class work to do in preparation for the series. These pieces will explore materials or content. The final 7 piece series completes the course assignments. The final series must use the unclothed figure in each piece.

In-class work from the model, in the form of the 3 better paper sketchbooks, will be submitted at the end of class, Tuesday, April 24th. Other in-class work and outside of class work, not from the model, will be due at the assigned times. The final series pieces are submitted at the beginning of class when due, allowing for critique.

Work that is late will receive a grade reduction of a full grade. In-class work is considered late if it's turned in after the end of class Tuesday April 24th. Critique work must be in class and pinned up before the critique begins in order to be on time. So, series work is late if it comes in after critique has begun. All series work are required, if any go un-submitted – meaning turning in less than 7 pieces, the course requirements aren't met and the course grade is an F.

A requirement for all work submitted for grade is to have your name and date on the back of the work.

The BFA standard is used to determine grades in A to F range, numerically that is a 4, 3, 2, 1, and 0 scale.

A B grade indicates the student draws at a level acceptable for a BFA student. A C indicates that the BFA level hasn't been maintained. An A is reserved for work produced above that BFA standard. Your responsibility to submit work on time is significant and because it is, to encourage that you do turn all work in on time, the grade is significantly reduced if it isn't.

In-class work is submitted after the last model drawing session, provisionally scheduled for Tuesday April 24th. The submitted work consists of the 3 better paper sketchbooks. (See chart above for the weighting of grades.)

There are 2 group pieces to produce that comprise the group work. There are outside of class pieces as well which are part of this grade.

The 7 piece series grade is determined by the quality of the final series pieces in presentation. It is a single grade.

To evaluate the quality of participation in requirements in the course, a preparation grade is given. This preparation grade is a weighted average of individual preparation grades given throughout the semester. The individual preparation grades are an all or nothing grade, either an A or F. There is no middle ground. The A grade is assigned when a student turns in specific work, finished and on time, or participates in group exercises or critiques. If work submitted is late or unfinished, or if the student doesn't participate in critique or group exercises, then the grade is an F.

Students participate in a number of distinct and unique types of activities that are used to determine this grade. The group work and outside of class work, the in-class work and the series work have events that require participation.

First, the group work requires participation in class for 2 days. Both events must be completed in order to earn the A. This will be 1% of the course grade.

Second, outside of class work when scheduled must be submitted as complete and on time to earn a preparation grade of A. This is also 1% of the course grade. If any of these are missed or not turned in the grade for preparation will be an F for 1% of the course grade.

Third, the in-class work is presented in a 2 day critique and submitted at semester's end for grading. The specific requirements that 5 pages of gesture and 10 pages of long poses must be met for the first critique and all 3 sketchbooks for the second. Participation in the critiques and submitting the work earns a preparation grade of A. If any one of the events

isn't completed the grade for the two is an F. This grade will be 1% of the course grade.

Fourth, the series requires 6 submissions throughout the semester. All 6 must be completed with the required numbers of pieces, all finished and on time, in order to earn the A grade. This grade is 3% of the course grade.

Unfinished work is at best a D grade. And all late work will receive a full grade reduction.

**Note A:** An additional requirement for the course grade, if an F grade is assigned for any one of the 4 graded areas listed at the top of the Grading plan, then the course grade becomes an F. There are many ways this F grade can be earned, from never turning in required work to turning in D work late, resulting in a grade reduction from D to F.

## Course grades.

There are 3 factors that determine your grade.

- 1. Add the grades for the 4 areas of above grading plan.
- 2. Per attendance policy: consult absences and use them to adjust course grade.
- 3. Per grading policy: receiving an F grade for any of the 4 graded areas, resulting in a course grade of F.

The purpose of the BFA Review is to ensure that students have learned basic principles and techniques needed for advanced art courses.

All Art students must successfully complete all of the Art Foundation courses and the BFA Review before being accepted into a BFA program in Computer Animation, Photography, or Studio Art or Graphic Design. Graphic Design students must also pass a separate Graphic Design Review after the BFA Review.

The Art Foundation Courses are WASH, Drawing, and Foundations in Digital Art. (ARTS 1313, 1314, 1315, 1316, & 2313). Students must pass each course with a grade of C or higher to take the BFA Review and proceed to upper level courses.

The semester after all of the Foundation courses are complete, students must sign up for the BFA Review. Students should see an art advisor every semester to ensure they take the BFA Review on time. It should be taken the semester immediately following the completion of the Foundation Courses.

Students who do not pass the BFA Review may re-take it the following semester. Students who do not pass on the second attempt will not be allowed to continue as BFA majors, but may follow the degree plan for the BA in Art. Non-participation after signing up or being advised to sign up will count as a failure of that semester's review.

Graphic Design students must pass the BFA Review, complete Principles of Graphic Design (ARTS 2323) and participate in a BFA Review at the end of the semester that they are enrolled in Typography (ARTS 3322).
