COURSE DESCRIPTION AND OBJECTIVES

MUSI 1310 is a survey of the history of rock and popular music beginning with their common origins in 19th-century popular and southern folk music, and continuing through the latest trends with discussions that include individual musicians as well as stylistic details. [Prerequisites: *none*]

The course provides students with the tools for understanding the interaction of music and civilization from a historical perspective with references to the visual arts, history, and popular trends as they relate to the development of the style of music known as "Rock and Roll."

COURSE ATTENTIVENESS AND ATTENDANCE

All information covered in the rock on! webpage is subject to appear on exams. Attendance will be recorded for this course. There will be a sign-in sheet available at the front of the hall. If you are late and do not sign in, see the professor after class to have your attendance counted at the professor's discretion. Every absence past the allotted 3 in this course will lower your grade 2%. For example, if you have a 90% at the end of the semester, and you have 5 unexcused absences, your grade is now an 86%.

ASSIGNMENTS

Students will be responsible for reading 2 chapters a week and take 2 quizzes by the end of that week. See the calendar section for the closing dates on the quizzes

There are many FURTHER EXPLORATION short answer questions. Choose only 1 question to answer per chapter: additional answers will not be graded. These are tweet-length comments and must be completed by the end of the semester (a total of 30 responses).

There is ONE STUDENT BLOG that you will contribute 1-2 paragraphs of input at ANY TIME throughout the semester. Must be completed by the end of the semester. The Student blog is on the side menu on the homepage of the text.

QUIZZES

ALL quizzes will be administered online on Kendall Hunt *ROCK ON!* course website. Each quiz will be available to you from the first day of class. The REQUIRED completion date is listed on the CALENDAR Quizzes not completed by that date will receive a grade of ZERO. There are **NO MAKEUPS for exams – NO exceptions**.

You are allowed **two (2) attempts at each exam** –the <u>higher</u> of the two attempts will be your exam grade.

To improve your grade, re-study, and review the materials. Then re-take the exam.

There will be 30 scheduled Quizzes in MUSI 1310. Each quiz covers the material discussed in each chapter. Each quiz is administered online in multiple-choice format consisting of 10 questions. Each Quiz may be re-taken once before its closing date. Your highest score is used.

Further Exploration short responses (10) 20% of FINAL GRADE

There are 2-4 FURTHER EXPLORATION questions in each chapter. Answer only one question from each chapter, 30 in total. Only one question will be graded per chapter.
