Course Description

CHEM 1406: INORGANIC AND ENVIRONMENTAL CHEMISTRY LECTURE AND LABORATORY.

This course is for non-science majors.

The elements and their compounds are considered from a non-technical standpoint with emphasis placed on the chemistry of familiar materials. This course will examine the relevancy and importance of chemistry to our daily lives and to relate the discipline of chemistry to other areas of study such as agriculture or nursing. Topics found in the media will be related to subject matter studied in the class.

The following topics are studied:

Measurements, Atoms and elements, Nuclear Chemistry, Compounds and their bonds, Chemical reactions, Energy and matter, Gases, Solutions, and acids and bases.

The text's authors have included a large number of problems at the end of each chapter that **strongly require your attention**. Many of these problems are answered in the back of the text, but you should go to those solutions (answers) only as a last resort. Don't cheat yourself of the learning by looking up the answer before you have really tried the problem.

Purpose of This Course

- 1. To provide the background in inorganic and environmental chemistry for students who are in the health career programs as nursing, dental hygiene, respiratory therapy, and radiological and nuclear technology.
- 2. To furnish knowledge of the terminology, techniques, concepts, and principles associated with the study of chemistry
- 3. To explore the history of scientific discovery
- 4. To become informed about the scientists who have contributed to our knowledge of chemistry
- 5. To provide information in inorganic and environmental chemistry that will enable them to read scientific articles in newspapers and magazines with understanding.

Exams

The laboratory portion of this course counts for 25% of the overall grade. In order to make a D or higher in this course, you must earn at least a D in both the lecture portion of the course AND in the laboratory portion of the course.

There will be four tests and a final in the lecture portion. (The scheduled test dates are not negotiable but can be changed at the discretion of the instructor). Your lowest Test grade will be dropped. The final exam is comprehensive (covers materials from chapters 1-10). Attendance Policy

Class attendance is **extremely important** to succeed in this course. Roll will be taken at class meetings. You are responsible for signing the class attendance sheet for each class session. Your signature becomes official documentation that you were in class; if you do not sign-in you will be considered absent. You will be considered absent if you do not attend the entire class period. That means, **late arrival**, **leaving class early** and **forgetting to sign the roll** sheet are counted as absences. If you are absent, it is your responsibility to find out what work you missed (either from the instructor or from another student) and complete all assignments by the due date. **Two extra points** will be added to the overall score for the students having **NO more than 2** absences for the semester. However, you must demonstrate class participation and professionalism to earn these two extra points.

Students will be allowed 3 class absences without penalty. Any absences over 3 classes will result in final grade reductions.

On-Line Quizzes, In-Class Quizzes and Homework

Note that the on-line quizzes, in-class quizzes and homework are required in this course. All the assignments must be turned in by the due date. Late assignments will not be graded. These assignments are used to reinforce lecture material; they will be assigned as the material is covered in lecture. These are meant to help the average student keep up and master the material assigned each day and covered in class.

The online quizzes are automatically graded as you take them.

Homework will be assigned every time we meet. Every Tuesday, either your homework will be collected, an in-class quiz (based on homework) will be given OR an on-line quiz will be given. Popup quizzes will also be given (weight of a pop-quiz is same as a regular quiz).

Missed Assignments (Online quizzes, In-class assignments, homework)

Missed online quizzes and in-class assignments result in a zero for that assignment. **They cannot be made up.** You are allowed to miss two in-class assignments without any penalties. Homework assignments are due the next class period after the absence. Late assignments will not be graded.

Missed Tests

There are no make-ups for unexcused absences on tests or the final. If you miss an exam for an unexcused absence, then your grade on that exam is zero.

Excused absences included sickness that involves a doctor or health clinic visit, death in the immediate family, and emergency situations like fires or automobile accidents.

If you have an excused absence and can't attend a test, when you supply documentation for your absence a make-up exam will be scheduled. It is your responsibility to contact me as soon as possible after the missed test to begin this process. If you do not supply that documentation before the next schedule test, then the missed test grade becomes zero. In other words, excused absences require documentation.

Academic Honesty
