CATALOG DESCRIPTION

This course introduces the major themes and developments in World History from 1500 to the present. Some of these topics will include the Renaissance in Europe, the Reformation, Conquest and Exploitation, the Enlightenment, the American and French Revolutions, the Industrial Revolution, Feminism, Nationalism, Imperialism, the World Wars, Decolonization, and the Cold War. We will examine the major political, cultural, economic, and social developments that occurred in human societies across Europe, Africa, Asia, and the Americas during this period as well as the cross-cultural interactions and exchanges that took place. Through the examination of primary sources, students will become familiar with the craft of history and will learn to think analytically.

COURSE OBJECTIVES

A) **Critical Thinking:** Students will gain a broad factual knowledge in the field of World History from the Renaissance to the Cold War. Students will be taught to think critically and analytically, and to ask appropriate questions about different historical societies and cultures, integrating and synthesizing knowledge they gain in the course, forming conclusions, and building an informed belief system from the complexity of information presented in the course content.

B) Communication Skills:

Communication skills will be addressed in this class through the reading and discussion of historical texts, through the lectures, and through the written assignments and exams. Visual aids such as films, political cartoons, maps, and photographs will be used during the presentation of course material. Students will learn through the use of historical materials to critically evaluate the time periods in which these materials originated.

C) **Personal Responsibility:** Personal responsibility will be addressed in this course as students articulate through exams and analytical assignments how to connect choices, actions, and consequences to ethical decision-making. By learning how individuals throughout this period of World History drew upon their cultural belief systems to make ethical choices, students will learn how their personal choices influence their own society.

D) **Social Responsibility:** Social responsibility will be addressed in this course as students learn the ways that individuals and groups throughout history made decisions aimed at improving society for all by promoting civic responsibility and participation, civil discourse, and other social values. As a result, students will discover their own social responsibilities for improving society.

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed. My specific policy for this class is as follows: all written work should represent your own efforts. If you quote directly from a source, you must give credit to the original author in a citation. The same standard applies when you paraphrase a source's words, and even when you use original ideas from a source. Failure to credit the source in these circumstances is called plagiarism—literally theft of someone's ideas and/or words. In addition, failing to properly paraphrase, that is, simply changing a few words from someone else's writing—even with a citation—is considered plagiarism. Both types of plagiarism are absolutely unacceptable. Cheating includes copying someone's answers to an assignment or vice-versa, allowing them to do work for you or vice-versa, or receiving or giving any other kind of unauthorized assistance. Cheating is not confined to tests, but also applies to daily work such as quizzes or notes. Any acts of plagiarism or cheating may result in a zero for the assignment that cannot be made up. A second act of cheating or plagiarism may result in expulsion from the course and an F for the semester. It is better to get a poor grade on an assignment using your own work than risking your integrity by cheating on an assignment.
