COURSE DESCRIPTION: Functional requirements of agricultural buildings; valuation, appraisal and estimating; structural requirements of agricultural buildings; planning and designing major service and processing buildings.

COURSE OUTLINE: Agriculture 3386 is a 2-2 course, 2 hours lecture and 2 hours laboratory per week. Lecture will include technical information, procedures, discussion, and problem solving activities. Lab will include problems and hands-on activities relating to the construction of agricultural structures.

COURSE OBJECTIVES: Upon completion of this course you should be able to:

- 1. Discuss economics and current trends of agricultural structures.
- 2. Discuss the planning of structures for given applications and loads.
- 3. Discuss building-site layout and location of specific buildings
- 4. Discuss site preparation, and foundations.
- 5. Select ingredients, calculate the amount, place, finish and cure concrete.
- 6. Discuss and plan various types of agricultural structures.
- 7. Calculate a bill-of-materials and develop a plan for an agricultural structure.
- 8. Discuss concrete construction and perform the related skills.
- 9. Discuss and select engineered wood products used in construction.
- 10. Discuss and select preservatives, and coatings and their use in construction.
- 11. Discuss and select fasteners used in construction.
- 12. Discuss and select insulation requirements and materials, and compute R-values.
- 13. Discuss and select ventilation and heating requirements.
- 14. Discuss alternate energy systems for structures.
- 15. Define common terms used in agricultural construction.
- 16. Select joists, beams, and columns for specific applications.
- 17. Discuss, select and install common roofing materials.

- 18. Read plans and estimate construction costs for agricultural structures.
- 19. Discuss environmental issues and waste management and handling for agricultural applications.
- 20. Discuss and plan agricultural fences and livestock containment and handling facilities.
- 21. Safely perform skills involved in the construction of agricultural structures and facilities.

CLASSROOM & LABORATORY PROCEDURES, ACTIVITIES, AND REQUIRED SUPPLIES: Students are to comply with the safety policies and procedures as demonstrated and outlined in the Safety Instruction for Ag Engineering Technology Center Document.

Each student is required to wear safety glasses and appropriate clothing and shoes during all laboratory/construction sessions. Students are not to operate tools and equipment until they have received proper training and are required to follow all appropriate industry safety procedures. One or more wooden, metal, and/or concrete construction projects will be performed during laboratory sessions. Students will keep the laboratory clean and in order. Laboratory sessions will not be dismissed until all tools and equipment is returned to the proper storage location and the floor is properly clean and swept.

DEPARTMENT OF AGRICULTURAL SCIENCES ATTENDANCE POLICY:

- 1. Regular and punctual attendance is expected of each student at Sam Houston State University.
- 2. Each faculty member will keep a written record of student attendance. Students will be expected to sign in for class and labs to comply with federal guidelines.
- 3. If a student misses four or more classes, the student's grade may be reduced by one letter grade. Additional penalties will be up to the discretion of the professor.
- 4. Three unexcused or unjustified tardies or early departures are considered one absence.
- 5. Excused absences must be documented by the student with a letter of confirmation from the sponsoring student organization, professor, doctor, etc. Exemptions will include participation in departmental activities when prior approval is attained from the Department Chair or the sponsoring professor. Excused absences and/or approved participation in departmental activities do not negate student's responsibility to complete any missed assignments or tests in a timely manner.

RESEARCH PAPER: 100 pts

Each student will be required to develop a research paper over a subject related to agricultural structures or environmental control. To avoid possible duplication of specific topics, *advanced approval of topics by the instructor* is required and will be granted on a first-come first-served basis. The paper is to have five typed pages of text plus a bibliography. At least four major references are to be listed. The bibliography and any tables, charts, pictures, etc. do not count as part of the five pages of text. The paper is expected to be neat as well as mechanically and grammatically correct. A printed copy must be submitted in class and an electronic copy must be submitted thru BB as a Turn-it-in Assignment. The system will check the paper for plagerism and originality.

No exams or assignments will be given at alternative times unless arrangements are made with the professor before the scheduled activity occurs.

1. At the discretion of the professor, up to a 10 % penalty may be assessed for late exams or assignments. At the discretion of the professor, a 100% essay make-up exam may be given. 2. Final Exam is comprehensive.

FIELD TRIPS: Field trips may be planned throughout the semester as student/instructor schedules and contacts with businesses and industries allow. Because of possible travel time from the SHSU campus, it may be that a field trip will take longer than normal class/lab schedules allow. If so, other class/lab release time may be given.

ACADEMIC DISHONESTY AND DISRUPTIVE CONDUCT: Students will refrain from behavior in the classroom or lab that intentionally or unintentionally disrupts the learning process and, thus, impedes the mission of the university. Students are prohibited from making offensive remarks, sleeping, talking at inappropriate times, wearing inappropriate clothing, or engage in any other form of distraction. Inappropriate behavior in the classroom shall result in a directive to leave class. Students who are especially disruptive also may be reported to the Dean of Students for disciplinary action in accordance with university policy. All students are expected to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of dishonesty in any phase of academic work will be subject to disciplinary action. The University and its official representatives may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating on an examination or other academic work which is to be submitted, plagiarism, purchasing papers, collusion and the abuse of resource materials. Any such action will result in failing that exam, research paper, assignment, or the entire course, and a letter of explanation placed in the student's file.

Cellular telephones, text messengers, any communication function on laptop computers, and/or any other similar devices *must be turned off before class or lab begins*. Arrangements for handling potential emergency situations must be arranged before the class or lab period begins at the discretion of the instructor. The use of any device that performs communication functions during any test period is prohibited. Such devices may not be used even for their calculator functions.

Failure to comply with this policy could result in expulsion from the classroom or lab, or with multiple offenses, failure of the course. These devices should not be present during a test or should be stored securely in such a way that they cannot be seen or used. Even the visible presence of such a device during a test period may result in a zero for that test. STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence. University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
