**Course Description:** Advance Studies in the Applied Discipline is an independent study course in which the student receives coaching and a series of assignments designed to further the student's development as a scholar in applied pedagogy and teaching approaches. This course of study will be tailored to each individual student's needs and aspirations.

**Course Objectives:** Our main goal is to become scholarly pedagogues. In order to achieve this we must work toward the following:

- 1.) Become familiar with many aspects of technique through the study and analysis of solo literature, etudes, ethnic styles, and writings of great applied teachers
- 2.) Create a database of teaching techniques

**Assigned Materials:** spiral notebook, note card collection or database

**Attendance:** We must meet for a minimum of twelve sessions in the semester to avoid a one-grade penalty. If you are unable to meet you should make every attempt to contact me about a problem before our meeting time. 24 hours advance notice is required in order for the session to be made up by the professor and thus avoid an F for the missed session. (If I am unavailable for our meeting, I will try to give you advance notice.) It is imperative that you CHECK YOUR E-MAIL REGULARLY for updates.

## Grades:

Meetings will count as 30% of total semester grade. A journal will be kept to record information discussed in meeting sessions.

Semester Project will count as 70% of total semester grade. Create a note card collection or database of techniques for teaching various topics related to the flute. Project will be due December 11, 2008.

A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused

within a reasonable time after the absence. University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and /or examinations are to be completed.
