Course Description

This course provides an introduction to mental illness and behavioral disorders, including the psychological, biological and social factors involved in the development, diagnosis, and treatment of psychopathology. This is primarily a lecture course, although students are highly encouraged to ask questions and be active participants in the learning process. In addition, this course will incorporate other instructional formats, such as in-class discussions, instructional and demonstrational videos, and in-class activities, to enhance the learning experience.

Course Objectives

Essential Goal: Learning fundamental principles, generalizations, and theories related to abnormal psychology

- Learn psychological principles and phenomena involved in the development and maintenance of abnormal behavior
- Prepare students for further study in abnormal psychology

Important Goal: Gaining factual knowledge (such as terminology, classifications, methods, and trends) related to abnormal psychology

- · Learn about the etiology, nature, and prevalence of psychological disorders
- Learn the methods and findings of important research related to abnormal behavior and psychopathology

Important Goal: Learning to analyze and critically evaluate ideas, arguments, and points of view related to abnormal psychology

- Learn to think critically about abnormal psychology, particularly when faced with opinions and ideas related to psychopathology in the popular media and other sources of information
- Learn to use knowledge of abnormal psychology when critically evaluating ideas and research in other branches of psychology or other disciplines of study

Course Requirements/Expectations

Students are encouraged to read all assigned material prior to class and come prepared to discuss related topics in the media and elsewhere. Please consider that all material presented in class, both in lecture format as well as in videos, etc., will be "fair game" for your exams.

Grading Plan

Exams: Your grade in this course will be determined by your performance on three exams and a

noncumulative final. All material presented in class (lectures, guest speakers, videos,

demonstrations, etc.) is "fair game" for your exams. All exams will be multiple-choice format.

Each exam and the final will be worth 100 points.

Make-up Exams: There will be no make-up exams. The only exception to this policy is severe medical emergency

(e.g., hospitalization) or death in the family. If this is case, you *must notify the instructor within 24 hours of the exam*. Also, you must provide the instructor with adequate documentation of your emergency, which will be verified. Format of the make-up exams (e.g., multiple choice,

essay/shortanswer questions, essay) is at the discretion of the instructor. Failure to take an exam or

the final exam will result in a score of zero for the missed exam/final.

F = 59.49 and below Attendance Policy

Regular and punctual attendance is expected and is important to success. Sam Houston State University policy is that no student will be penalized for three or fewer hours of absence. However, a student may be penalized for more than three hours of absence. Students may miss one class without penalty to their grade. *Missing two classes, however, may impact your grade for the class*. The three hours of absence provided by university policy should be used carefully for serious illness and emergencies. If a student has a conflict with a scheduled class, he or she must meet with the instructor to determine an appropriate plan of action. It is the student's responsibility to contact the instructor regarding make-up work, and arrangements must be arranged with the instructor *prior* to the absence or *as soon as possible* after the absence, in the case of an emergency.

Electronic Devices

Students are *prohibited* from using or having in sight any electronic devices, which includes all cell phones, laptops, iPods (and similar devices), Blackberry devices, pagers, etc. All such devices should be placed in a silent or vibrate mode and stored out of sight during class to ensure no disruptions. See the instructor if you would like to have an exception to this prohibition considered. The use of any electronic device during exams is *strictly prohibited* and such devices should be stored securely during examinations. Even the visible presence of such an electronic device *may result in a score of zero* for an exam. Academic Dishonesty

Visitors in the Classroom

Only registered students may attend class. Exceptions can be made on a case-by-case basis by the instructor. In all cases, visitors must not present a disruption to the class by their attendance.
