# **Course Description**

This course includes an introduction to behavioral disorders. Biological and social factors in the development, diagnosis, and treatment of psychopathology are studied. This course will include lectures, in-class discussions, instructional and demonstrational videos, and in-class activities. A major goal of the course is to promote greater awareness and knowledge of psychopathology in hopes that we can be aware of and reduce the suffering and stigma associated with mental disorders.

# **Course Objectives**

Essential Goal:	Learning fundamental principles and theories related to abnormal psychology

Important Goal:	Gaining factual knowledge (such as terminology, classifications, methods, and trends) related to abnormal psychology	

• Learn about the etiology, nature, and prevalence of psychological disorders

- Learn the methods and findings of important research related to abnormal behavior and psychopathology
- *Important Goal:* Learning to analyze and critically evaluate ideas, arguments, and points of view related to abnormal psychology
  - Learn to think critically about abnormal psychology, particularly when faced with opinions and ideas related to psychopathology in the popular media and other sources of information
  - Learn to use knowledge of abnormal psychology when critically evaluating ideas and research in other branches of psychology or other disciplines of study

#### **Course Requirements/Expectations**

Please consider that all material presented in class, both in lecture format as well as in videos, etc., will be "fair game" for your exams. Consequently, attendance is important for success.

#### **Grading Plan**

Exams:	There will be three exams in this course. However, only your two height grades will count towards your final grade. Students who are happy with their grade on the first two exams can opt out of taking the third exam. It is strongly recommended that students opt to take the third exam if they do not receive an "A" on their prior two exams. All exams will be multiple-choice format.
Make-up Exams:	There will be no make-up exams. The only exception to this policy is severe medical emergency (e.g., hospitalization) or death in the family. If this is the case, you <i>must notify the instructor within 24 hours of the exam</i> . Also, you must provide the instructor with adequate documentation of your emergency, which will be verified. Format of the make-up exams (e.g., multiple choice, essay/short-answer questions, essay) is at the discretion of the instructor. Failure to take an exam or the final exam will result in a score of zero for the missed exam.
Movie Project:	This group assignment will involve watching and writing a group paper on a film (from a list of suggestions) that depicts some form of psychopathology. This assignment allows you to assume the role of diagnostician and to apply the knowledge you have gained in this course to a practice patient. It is also geared towards encouraging students to think critically about popular depictions of psychology and mental health. More detailed information on this project will be provided on Blackboard, anfd will be discussed in class. Groups will be made up of 5-6 people, and will be assigned on Blackboard. You will have three designated class periods to work on the movie project with your group. However, it is important to work on the project outside of this time as well. The final project will be due as a group on Blackboard on April 26 <sup>th</sup> at 11:59pm.

- **Participation** Listening to a lecture for 80 minutes is TOUGH! So, each class will include several opportunities to think, write, and discuss the class material. Please bring paper and a writing instrument to every class. Your written responses to in-class discussion questions and activities will be collected for participation. Given that the last exam is optional, to ensure student participation during the last 3<sup>rd</sup> of class, participation will be more heavily weighted during this period such that a total of 5 points will count towards the first 2/3<sup>rds</sup> of class, and 10 points towards the last third.
- *Extra Credit:* If you wish to earn extra credit in this course, you can do so by participating in research or practicum experiences conducted by members of the Department of Psychology and Philosophy. There are many different options posted on the PeRP system throughout the semester, however, all extra credit must be completed and assigned to the course by 5 pm on the last day of classes (May 3, 2018). Any credits assigned after this time will not be counted towards your grade. Each study on the PeRP system is assigned a number of "credits" and each credit you complete, up to 3, will be added to your overall grade at the end of the semester. So, for example, if you are at an 87 and you completed 3 credits on the PeRP system, you will end the course with a 90. Keep in mind that if you sign up for a study and you "no-show", you will receive negative credits. Negative credits on the PeRP system will count against your overall grade. #### **Attendance Policy**

Attendance is expected since tests will focus on the information from the lectures and class discussions. Attendance is necessary for your participation grade; however, this class does *not* carry a "failure due to absence" policy. Keep in mind that attendance in this class is highly correlated with your overall grade (including grades on exams!).

#### **Electronic Devices**

With the exception of laptops for taking class notes, students are *prohibited* from using or having in sight all other electronic devices, which includes all cell phones, iPods (and similar devices),

etc. All such devices should be placed in a silent or vibrate mode and stored out of sight during class to ensure no disruptions. See the instructor if you would like to have an exception to this prohibition considered.

### **Academic Dishonesty**
