CONDUCTING II — MUSI 4224 (Instrumental) SPRING 2018 SYLLABUS

COURSE DESCRIPTION:

Conducting II will cover intermediate and advanced level skills in conducting with a focus on conducting and rehearsing instrumental ensembles. Most topics will apply to both instrumental and choral conducting, however the course will focus on instrumental literature and ensembles. Topics will include advanced technical and expressive gestures, building musicianship and artistry, score study and preparation, rehearsal techniques, and professional development. Assignments will include written work based on professional development materials, readings, in-class conducting (individually and with an ensemble), video assignments, attendance quizzes, and exams. Students will regularly conduct an ensemble created by ALL the members of the class (singing and playing their instruments).

REQUIRED MATERIALS:

Metronome (phone app works); Baton; Binder; Video recording device; Instrument; 2 3-5 pound hand/wrist weight, tennis ball.

RECOMMENDED BUT NOT REQUIRED MATERIALS:

3–5 lb kettle ball; various lengths bungee cords; bosu ball

EXPECTATIONS:

- Class starts on time. No exceptions. It is unacceptable to start a rehearsal late, so don't do it here. Set up for this class will be minimal, but plan on arriving early to aid in set up for in-class ensemble. Everyone is expected to help.
- All written assignments must be proofread and contain minimal errors in punctuation and grammar. If there are too many errors, your paper may be returned, in which case you will have a chance to correct those errors, but it will lower your grade by one letter.
- Some of the things I will be saying to you will be subjective (i.e. my opinion on what is good and what isn't). *You are allowed to disagree*. However, you have to do it my way in class for the assignment *in order to pass the class*.
- You will have to *change* to pass this class. I will take you where you are at, and I will push you to improve. This will require a substantial shift in how you think about

- conducting, preparing to conduct, and maybe even how you view yourself as a conductor. This can be difficult. If you resist the change, it is even harder.
- Sheet Music: You are expected to organize, mark, and maintain your own copies of all music handed out in class.
- Dress professionally when you are conducting in class. (Casual attire is acceptable for video assignments.)
- This class is designed to develop the mental and physical skill necessary to be an effective conductor and educator. As a result, practicing conducting is a crucial component of successfully completing the class. In order to get a good grade in the class, you should expect to do about 5 hours of conducting practice per week. This is in addition to the written assignments and readings.

GRADING POLICY:

Assignments will be given either a letter grade (A=90–100, B=80–89, etc) or 100 for completion and 0 for failure to complete or turn in assignments. The instructor will inform you of the grading policy for each assignment. Assignments will be weighted according to difficulty, preparation time, and importance.

Make-up Assignments

In-Class Conducting CANNOT be made up. Late video and written assignments will be lowered by one-half letter grade for each passing class meeting.

In-Class Conducting

You will be expected to perform (as a singer and instrumentalist) for your classmates on a regular basis. Forgetting your instrument will lower your daily grade. Permission to sit-out must be approved by the instructor.

NOTE ON SCORE MARKING – One topic covered in class will include score study and score marking. As this topic is studied, you should mark your scores accordingly. A general harmonic analysis and phrasal analysis should be complete for any score you conduct in class.
