Policies & Expectations

- Depending on number of students, class will be divided into multiple groups (trios and/or quartets) led by a senior or a graduate student.
- Each group is responsible for setting up their rehearsal times (a minimum of two hours per week) outside of coaching.
- Group is responsible for choosing level appropriate music. Choosing music that is too difficult will be detrimental to your progress as a group.
- The ensembles are expected to come to coaching prepared and on time.
- Absences are unacceptable except in the case of an emergency.
- Depending on number of groups, I will coach each group every two to three weeks.
- Instructor coachings will begin September 8.

- You are graded based on the following criteria:
 - o Individual preparation (don't be the weak link. Practice your part)
 - o Group preparation
 - o Overall semester performance (I will hold you accountable for your level of preparation throughout the semester)

Student Absences on Religious Holy Days Policy

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
