This course is offered to undergraduate keyboard majors. The student earns one semester credit hour. In this course, a complex vocal and instrumental chamber music repertoire is surveyed, prepared and coached by the instructor of this course.

### LEARNING OBJECTIVES

The purpose of this course is to ensure that students have the opportunity to further develop their skills and knowledge of the piano accompanying repertoire. The repertoire studied will enable them to deal confidently in the professional piano accompanying music world.

# EXPECTED STUDENT OUTCOMES

- Learn the process of preparing music for exacting performance, without the leadership of a conductor. This involves working out the mechanical aspects of staying together and executing musical gestures, learning how to to collectively develop an interpretation of the work being studied, and acquiring the interpersonal skills necessary for a musician to function in a small group.
- Acquire knowledge of chamber music repertoire for the particular instrumentation of the group, through preparing and reading chamber music of different styles, historical periods, and composers.
- Develop the non-musical skills necessary to successfully participate in a chamber music ensemble. This begins with selecting a name for the group, and can continue with arranging the performance, designing an outreach concert or educational residency, planning verbal comments to the audience, writing notes for a printed program, writing a press release on the event, and any other such tasks such as your coach may assign.
