safety and health acts, OSHA rules, the duty to comply with standards, Record keeping, Employers' and employees' rights, Hazard communication, Inspection and investigation, Criminal enforcement of violations. The students will have full understanding of contesting citations, judicial review of enforcement actions, and ethics in safety at

work place.

Course objectives:

Students will explore issues in criminal liability for individuals and corporations under the OSHA Act and state criminal codes. Student will learn methods for achieving and maintaining OSHA compliance, using specific case studies to illustrate ways to avoid or minimize the impact of legal issues. The text addresses not only OSHA regulations and standards but also the legal aspects up to and including OSHRC decisions on specific issues. Additionally, the author examines the ethical issues involved in many of the legal aspects of the safety issues as well as ethical issues in the day-to-day management of safety and health.

Topics:

This course systematically addresses

- Provides methods of achieving and maintaining OSHA compliance
- Explains how to avoid potential liability in the safety and health arena
- Includes detailed examples of and checklists for protocols used by OSHA
- Presents an engineering approach to the integration of ethics into the design and business operations
- Supplies a working knowledge of the appeals process from the informal conference stage through an appeal to the U.S. Supreme Court
- Explores the murky area of criminal liability for individuals and corporations under the OSHA Act and state criminal codes
- > Includes a guide to legal issues involving OSHA and the potential legal areas of liability to avoid

Course vs. objectives:

The course supports the following outcomes in providing the students with:

- ➤ Elucidate the potential legal and ethical issues of the new industrialized workplace.
- ➤ Proactive approach to avoid or minimize potential liabilities, where possible, but also gives you the tools to be prepared and knowledgeable in the unique appellate process with OSHA and the OSHRC.
