COURSE DESCRIPTION:

Victimology is the study of victims. Within this course, you will learn about the development of victimology as a subfield of criminology, victimization trends, and the relationship between victims, offenders, and society by using crime specific categories. This course will cover theory, research, and policy implications related to the experience of victimization.

Many of the topics we will cover are sensitive, controversial, and emotional. During class or while reading assignments, you may find some of the material uncomfortable or unsettling. Moreover, students may find topics uncomfortable because of past experiences or the experience of loved ones. Given millions of people worldwide have been victimized, it is highly likely someone in our class has experienced some type of victimization. Please show respect for your classmates. You will never be forced to participate or watch videos that make you

uncomfortable. If at any point you feel uncomfortable, please excuse yourself from class for a few moments.

If the material brings up these feelings, or you are in a relationship you think is abusive, I urge you to:

- Talk to a trusted family member, friend, or mentor
- Seek help and support from: SHSU Counseling Center, National Domestic Violence Hotline, or the 24 hour national suicide hotline.

COURSE OBJECTIVES:

- 1. To garner an understanding of the **factual knowledge** of victimology, relating to knowing key terms, classifications/typologies, and research methods
- 2. To understand the **fundamental principles and theories** of victimology
- 3. To **apply course material** to the experience of crime victims across different crime types
- 4. To **critically evaluate** other ideas, points of view, and arguments as they relate to the study of victimology

COURSE REQUIREMENTS:

GRADING:

Grades will be based on four exams. There will be four standard exams that will be administered via Blackboard. Exams will be 50 multiple choice and/or true/false and will each be worth 20% of your grade.

Four crossword puzzles will be assigned. Crosswords will be due the class before each exam. Full credit will only be given to complete and correct crossword puzzles. They are due at the beginning of class, *before* lecture begins. Crossword puzzles must be submitted directly to the Professor. You cannot hand in another student's crossword puzzle. Do not hand the crossword puzzle in once class has started. Crossword puzzles submitted at the end of class will be considered late and will be marked down 1 full letter grade. Unless there is medical documentation, crossword puzzles will **not** be accepted after their due date.

Please keep in mind, I do my very best to respond within 24 hours, typically during normal business hours (8:00 am - 6:00 pm). Responses are highly unlikely during off-peak business hours (6:00 pm - 8:00 am).

CLASS CONDUCT POLICY

Students are expected to behave appropriately during class. The professor is the final arbiter of what behavior is appropriate and inappropriate. However, students should be guided by the following principle: Your behavior should not be disruptive or distracting to the instructor or your classmates. The following list of appropriate behaviors is not exhaustive.

- 1. Come to class on time. Your late entrance is distracting to everyone.

- 6. Be respectful.
- 7. Students may only use laptops for taking notes. Please check your Facebook or update your status after class. If you are using a laptop for any other reason besides note taking you will be asked to leave.
- 8. Complete readings prior to class and be prepared for discussion in class.
- 9. You are responsible for all readings whether or not they are covered in the lectures.

If the Professor finds that you are behaving inappropriately, you will be given one warning. The second instance of inappropriate behavior will result in expulsion from the class for the remainder of the day. My expectation is that nothing more than a warning will be required. If the behavior continues, your final grade will be reduced by one letter grade and you will be referred to the Dean's Office.
