### **Course description**

This graduate seminar series will focus on current topics and research in forensic science.

# **Course Objectives**

The purpose of the graduate seminar is to expose students to original research, new topics, or current issues in a wide variety of forensic disciplines. Students are given the opportunity to engage in active dialogue with an expert in the designated field. The seminar should help the students *apply* their scientific knowledge to actual casework, assist with problem-solving, and broaden their scope of understanding. Students are given the opportunity to engage in active discussion about the different ongoing research projects and data. The seminar should help the students apply their scientific knowledge to actual casework, assist with problem-solving, and broaden their scope of understanding.

### Grading

Students are required to actively participate in the seminar series by engaging speakers, asking questions and other activities directed by the instructor. Each student will be required to make at least one oral presentation during the seminar.

There will be no examinations. This is a seminar series requiring active participation from the students. Participation is required in and out of the classroom. The instructor may request feedback electronically or in hardcopy form. The entire grade is based upon attendance (17.5%), participation (17.5%), student feed-back/evaluations (17.5%), final performance during their oral presentation (17.5%) and FSAT evaluation performance (30%). Students are required to present an overview of their research (15-20 minutes, excluding questions) including aims, forensic significance, hypotheses and results/findings (to date).

Final grades will be based upon the following scale: 90 plus an "A"; 80 to 89 a "B"; below 79 a "C". Students should not count on a curve of the final grade. The instructor reserves

the right to modify the grading scheme to accommodate for a missed test or final examination in extenuating circumstances. The instructor also reserves the right to assign a final exam grade of 0% should he deem the absence was not properly handled or was unjustified. Appeals will be handled in accord with University Policy Statement 900823, Academic Grievance Procedures for Students.

### **Attendance Policy**
