Make sure your copy is complete through the 2013 legislative session. The *Texas Penal Code* is available online. Bring either the text or printed versions of the assigned sections with you to each class. Each student must have his/her own copy of the Texas Penal Code.

**COURSE DESCRIPTION:**

A course in the substantive criminal law which includes definition of law, definition of crime, general principles of criminal responsibility, elements of major crimes, punishments, and conditions or circumstances which may excuse from criminal responsibility or mitigate punishment. Particular emphasis is on the penal laws of the State of Texas.

**COURSE OBJECTIVES:**

1. Acquaint the student with the basic principles that underlie the American system of criminal law.
2. Acquaint the student with the elements of the primary criminal offenses using primarily the Texas Penal Code as illustration.
3. Improve student analytical and abstract thinking skills.

## COURSE REQUIREMENTS:

### *Examinations*

There will be three major examinations. Each may be comprehensive. The first and second exam will each count 30 percent toward the final grade. The last exam, given at the prescribed time of the final, will count 40%. No make-up will be allowed for any exam that the student misses, unless prior notification and agreement with the professor, with VERY GOOD REASON for allowing a make-up. If no notification is made, the student will receive a 0 for the examination regardless of the reason. Written and verified justification may be required if notification is made prior to the beginning of the exam, Oversleeping is not a justification and will not be accepted.

Examination questions for the major exams will come from the *Texas Penal Code* or class discussion. Any discussion of subjects in class are subject to testing, including scenarios that require application of material discussed. Additional topics or sections from the Penal Code may be added during the semester. The Examinations may be comprehensive.

Test answers will normally be reviewed at the following class session. In incidences where the professor determines that more than one correct answer exists for a question, credit may be awarded for an answer in addition to the keyed response. To gain benefit of this change, the student must be present at the review session.

During major exams, students may use any notes on paper, any book or papers including a copy of the *Texas Penal Code*. No computers or cell phones or any other digital device will be permitted. Exam questions will be fill in the blank or true/false. Make-up exams may be essay.

Failure to follow directions during examinations will result in a reduction in the grade.

## GRADING:

Final grade determination will be based upon 100 possible points. The three tests will count 100% of the final grade. Letter grades will be determined using the following scale: 90-100 points an "A"; 80-89 points a "B"; 70-79 points a "C"; 60-69 points a "D"; and less than 60 points an "F". Students should neither depend on nor expect a "curve" or other statistical modification of this grading schedule.

Students arriving to class three minutes after the time that the class is scheduled to start will have 1 point for each occurrence deducted from his/her final grade.

## MAKE-UP EXAMS:

No make-up exams will be given for the major exams unless arrangements have been made prior to the examination.

## ATTENDANCE POLICY:

Attendance will be recorded pursuant to University policy.

*Academic Dishonesty*

*Religious Holy Day Policy*

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: “a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20....” A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence. University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed. ## USE OF TELEPHONES AND TEXT MESSAGERS IN ACADEMIC CLASSROOMS AND FACILITIES

Even the visible presence of such a device during the test period will result in a zero for that test. Use of these devices during a test is considered *de facto* evidence of cheating and could result in a charge of academic dishonesty.
