Methodology:

Course will consist of lecture with lab assignments.

Grading: There will be 2 major exams during the course of the semester. Each of these will count as 20% of the total grade. Makeup exams must be scheduled with the professor within a week of the missed exam. A makeup exam will not necessarily cover identical material to the missed exam, and may be of a different format and difficulty level. There will be a final exam which will count as 30% of the grade. There will be several homework and lab assignments which will count as 30% of the grade.

Grading Scale: The following grade scale is used:

 Absences: In accordance with University Policy, regular attendance is required; however, no point will be awarded or subtracted based on your attendance.
