Course Description:

Students in this senior seminar style capstone course will synthesize and integrate topics within

victim's studies to include: family violence, child abuse and neglect, elder abuse, stalking, human trafficking, other violent crime victims, victim services delivery, and evaluation. Capstone courses are designed to allow the student to "pull it all together" and apply what they have learned in the victim studies program to a real problem or agency. Students will have the opportunity to apply concepts and theories in a hands-on setting within a local victim service program. This experience will culminate in a research paper and class presentation at the end of the semester.

Classroom Demeanor:

Issues surrounding victimology involve many sensitive topics. For example, estimates of the prevalence of family violence suggest that the vast majority of college students have either directly experienced some form of family violence or have a close friend or family member who has been a victim of family violence. It is imperative that we are mindful of these facts in discussing topics across the semester. It is my policy that I will not allow any form of joking, sarcasm, or otherwise insensitive remarks about violence during this course. Students found to be in violation of this policy will be immediately dropped from the class.

In addition, some topics may be disturbing to students. Course Objectives

- 1. To gain *factual knowledge* (terminology, trends, and concepts) of the estimates of prevalence, severity, and types of violence.
- 2. To analyze and critically evaluate an area and agency in victim services.
- 3. To learn to *apply course materials to improve thinking and problem solving* abilities regarding issues in victim services.

Student Learning Outcomes:

- 1. Learn to synthesize various types of information regarding victim studies and victim services.
- 2. Understand how victim service providers operate within an agency organizational structure
- 3. Improve oral and written communication skills
- 4. Develop professionally in preparation for entering the job market in victim services.

<u>Course Requirements</u> (See Class Schedule for Due Dates for all Required Work)

Exams: (3 X 20 Points Each = 60 Total Points): SLO #1

Each student is required to take three 20-point examinations, for a total of 60 points. These exams will consist of multiple choice and true/false questions. Some questions requiring short written responses may also be included. Questions will be composed of information from the textbook. In the event of an *extenuating circumstance* and with *prior notice* to the Professor, students may make up **ONE** exam during the semester. All make-up exams will be given during the **week before finals (final presentations) week (Week 15: April 30-May6).**

Seminar facilitation: (5 Points): SLO #1 - 4

As this is a senior seminar course, students will be paired up to facilitate a topic discussion for each week. I will make the schedule after the first class session. This means that one or two students will have researched the topic more in-depth and will bring hand outs and materials to discuss with the class for 30 minutes at the beginning of the class period. There will be <u>NO Make Up</u> opportunities for this required activity. This serves as an important component for any senior capstone experience. Please be sure to complete this requirement.

Agency Research Project SLO #1-4

Students will have the opportunity to engage in a "hands on" project this semester. This can happen two ways:

- Locate a local victim service agency and research everything you can about them. Visit the agency several times during the semester. Observe. Collect data and information. Conduct interviews with the heads and directors. Learn about their challenges and successes. Understand their financial and funding systems. Synthesize their services and programs. Gather data on the number of clients served in a year, the number of programs run, shelter statistics, court information, law enforcement issues, etc. All things that are relevant to your particular agency.
- 2) For students who cannot physically visit an agency for any reason, complete all of the activities above but via telephone, email, internet searches, etc.

Students will submit a 20 page (15 page hard minimum but no longer than 25 pages) capstone paper at the end of their hands-on experience. The paper will be typed, double spaced, Times New Roman, 12-point font, one inch margins all around, with a cover page. Full references must be included in the paper and in a reference page. Use APA format for citation style. The other paper formatting can reflect other styles but should have major heading and sub-headings. The rubric for grading this paper is attached.

*****Agency selection is due to me no later than January 25. You can email it to me or give it to me in class on the 25th.

Student Research Project Presentation: SLO # 3 - 4

Students will make a 10 minute presentation to the class at the end of the semester. A sign-up sheet

with presentation dates will be distributed in class during the second week. Look at your calendars now:

It is expected that ALL students will attend ALL presentations out of respect and professional courtesy to your colleagues. Missing more than one presentation date without approval from the Professor will result in a <u>one letter grade reduction on your own paper</u>.
