Required Materials

Course Objective: To develop an understanding of and facility for the concepts and applications of mathematical probability and inferential statistics.

Course Description: Topics include basic concepts and properties of probability, random variables, statistical distributions, measures of central tendency, variance, covariance, correlation, functions of random variables, sampling distributions, the Central Limit Theorem and statistical inference.

Prerequisite: Math 4371 and (Math 2440 (Calculus III) or taking it concurrently.)

Tests & the Examination: There will be two (2) tests during the course of the semester and a mandatory comprehensive final examination. Test dates are scheduled for **Thursday, Feb. 15** and **Thursday, Mar. 29**. The comprehensive final examination will be held on **Thursday, May 10, 2018, (5:00 p.m. – 7:00 p.m.)**. *Makeup tests will **NOT** be given. If a test is missed, its grade will be replaced by the Final Examination grade.*

Homework and Quizzes: Homework assignments are given daily and should be regarded as the *minimum* necessary for a full understanding of the material and success on the tests and comprehensive final examination. I will generally post homework assignments on **BlackBoard®**. We will also have short pop quizzes, which will be graded and returned usually by the next class period. Since I am looking for spontaneity, there is no opportunity to make-up a missed pop quiz. Pop quizzes, in the aggregate, will contribute to the final point total.

Notes:
