

**COURSE DESCRIPTION**– This course provides an introduction to substance use and abuse through an examination of the history of drugs, drug laws and the development of criminal justice policies as they relate to drugs. In addition, the biological, social, and theoretical perspectives about drug use is examined. Details relating to the specific characteristics of the various categories of drugs and methods of prevention and intervention are highlighted throughout the course.

#### **COURSE OBJECTIVES**

1. Understand the relationship between drugs and the criminal justice system.

2. Learn the fundamental principles, perspectives, and theories of drug use and abuse to include the terminology related to both legal and illegal substances.

3. Understand the drug taking behaviors and the strategies used for prevention and intervention.

#### **COURSE REQUIREMENTS –**

There will be four exams, consisting of multiple choice worth 50 points each for a total of 200 points. Students are also required to submit 5 journal entries worth 40 points each for a total of 200 points.
