**Course Description**

It is essential that criminal justice professionals be socially aware of the cultural differences in society, and the importance of the perception of fairness in how the criminal justice system creates, enforces, and carries out policy and justice. Research in criminal justice and criminology often points out the disparate rates at which minorities are involved in the criminal justice system. The focus of this course will be to examine multicultural issues in the realm of criminal justice and society.

**Course Objectives**

1. Analyze the interactions of class, race/ethnicity, and gender in relation to criminal justice policies, actions, responses, and outcomes.
2. Explore theories, roles, and/or methods concerning the interaction of the criminal justice system with a diverse, multi-cultural population.
3. Understand the nature of the link between crime policies and class, race/ethnicity, and gender.
4. Evaluate current events relating to minority interactions with the criminal justice system.

## **COURSE REQUIREMENTS:**

### **Course Requirement - Discussion Board Participation/Attendance (15 x 20 =300 Total):**

There will be 15 Discussion Questions (one per each week's session), worth 20 points each. You are expected to make a minimum of *two* posts to each week's Discussion Board Question. These will include your initial response to the Discussion question, and at least one comment on a classmate's response to the Discussion question. Your initial response should be submitted by 11:59pm [CST] on Wednesday night of each week's session. Your final comment to a classmate should be submitted by 11:59pm on Sunday night of each session. All comments should be contributions which advance the quality of the discussion. Please include source citations (from textbook or article). Credit will not be given for incomplete discussions, so be sure to post at least twice to each Discussion Board.

### **Course Grading**

#### **Possible Points (500):**

1. Discussion Attendance/Participation = 15 Discussion x 20 points each = 300\*
2. Exams = Two exams (one mid-term/one final exam) x 100 points each = 200\*\*

\*Discussions will be graded weekly, but only after *all* of the requirements have been met.

\*\*Exams may consist of short answer, true/false, and/or multiple-choice questions. Exams will usually include only the information found in your textbook reading assignments, but may include information from the weekly Discussion Boards.\*\*
