Course Description: An introduction to the implementation of common business applications using current visual application development platforms. Basic structured and object-oriented analysis and construction techniques are taught in the context of the creation of business-oriented systems. Prerequisites: CS 133, CS 143, or GBA 180, and MTH 199.

- Analyze given problems and develop effective algorithms.
- Apply key concepts of structured programming (e.g. control structures).
- Apply key concepts of object-oriented programming (e.g. classes/objects and methods).
- Apply key concepts of event-driven programming (e.g. Windows forms/controls and events).
