Course Description:

Applied clarinet lessons are designed to give students an overview of clarinet repertoire, fundamentals, history and pedagogy through assignments based on expertise and needs of the individual student. Through independent practice, lessons and solo performances, the course objectives can be obtained. The degree plan in which you are enrolled does not alter the perception of your goals. Each student will be expected to develop his or her performance skills to the greatest potential.

Course Objectives:

Textbooks and Required Supplies:

<u>Music</u> Students are assigned new repertoire, etudes and technical exercises each semester. It is the responsibility of the student to obtain this literature as it is against the law to copy music. A list of recommended music dealers is located in the clarinet handbook.

<u>Equipment</u> Good working equipment is needed to obtain the course objectives. This implies an adequate supply of quality reeds. **All students are required to own a metronome and tuner.** A list of recommended mail order resources is located in the clarinet handbook.

<u>Notebook</u> Students are required to keep handouts and repertoire information performed in studio class in a 3-ring binder.

<u>Accompanist</u> The majority of clarinet repertoire requires an accompanist. It is the student's responsibility to obtain, arrange rehearsals and pay the pianist. The student must bring the accompanist to lessons beginning approximately 6 weeks prior to the recital.

Attendance Policy: Each student will be assigned a lesson time and will receive one graded lesson per week. Unattended lessons will not be rescheduled and will result in a failing grade. Illness is excused once a doctor's note is obtained. At this point, a makeup lesson may be arranged. If you are unable to attend a lesson, please let me know as this is a common courtesy. Lessons will begin the week of January 22 unless otherwise arranged.

At the beginning of the semester, students must complete a lesson schedule form. Include two preferred lesson days and times. Lesson times will be determined in consultation with the student's lesson schedule form. If your schedule changes, it is your responsibility to inform Dr. Card. Every effort will be made to accommodate the student's schedule. The master schedule will be posted on Dr. Card's door.

Attendance is mandatory at studio class for all clarinet concentrations unless there is a class conflict. Studio class will address clarinet pedagogy, literature, and history as well as clarinet chamber music (clarinet choir, quartets, trios and duets). Thursdays at 2:00 in Room 219 and Recital Hall.

Students are encouraged to attend as many faculty, professional and student concerts as your schedule allows. It is crucial you support your peers and experience a wide range of music. Attendance is **REQUIRED** at all the following clarinet events:

Please be aware the School of Music has a concert attendance requirement. Students must attend 12 concerts during the semester (9 faculty and 3 student) for a total of 6 semesters. Transfer students are credited up to 3 semesters. Refer to the student handbook or ask me for further information.

Assignments: Weekly assignments consist of select technical exercises, complete etudes and repertoire. Other assignments will be given depending on the needs of the student. Lessons will consist of the prepared assignments and sight-reading. These assignments are accomplished through daily practice outside of the applied lesson. We recommend a minimum of 10 hours a week for music therapy/education majors; 15 hours a week for performance majors. This is only a guideline since each student is unique and may require more practice time to achieve weekly goals.

Staff Accompanist: Two forms, piano music in a binder and \$100 blank check are due to Dr. Rus by 12:00 on Monday 29. You must attend a **mandatory** meeting for ALL students giving a recital in the Spring Semester of 2017 on Tuesday 30 at 4:00 in her office, Music Building #330.

You must contact Dr. Rus if you have a conflict and need to meet at a different time. (ilonkaru s@yahoo.com or text at 832 606 5388)

At the beginning of the semester, obtain a recital packet from the Music Office. The packet contains a Recital Date form, Recital Hearing form, and Program form. In consultation with the applied teacher, all recital performers and Kelli Irwin, select a recital date. It is best to arrange a dress rehearsal in the performance hall, usually a day or two prior to the recital. Check with Kelli for availability of the hall. The staff accompanist must be informed of the dress rehearsal date four weeks in advance.

The staff accompanist should attend all lessons approximately 6 weeks prior to the recital. Please inform your pianist of this date. A Recital Hearing must be scheduled at least two to three weeks prior to the recital date. All performers must be present at the hearing. At this time, program and program notes are due. Notes for each piece should consist of approximately 150 words, typed. Program notes must be original prose; do not merely quote a source or plagiarize. No hand written documents will be accepted.

Exams: Two exams, or juries, are administered near the end of the semester for all clarinet majors and concentrations. Technique Juries will be during the week of **April 16 unless otherwise rearranged**; Repertoire Juries will be heard on Monday and Tuesday, **May 7 and 8.** If a student receives a passing grade on the recital, the repertoire jury is waived.

Grading: The assigning of grades in applied music is, to a great extent, a subjective decision based on the teacher's view of the student's growth. There is a careful weighing of the quantity and quality of your work throughout the semester. Overall grade for the semester is based on the following:

Weekly Lessons (50%)

The weekly grade will be determined by the preparation and performance of the student. Quality and consistency play an important role as well as attitude toward playing. Unexcused absences will receive an F for the weekly grade. Fulfilling the pianist requirements for juries will also be included in this section.

Recital (20%)

Includes the Recital Hearing, program notes and recital performance.

Technique Juries (10%)

Attendance (10%)

Studio class and recitals/concerts

Clarinet Notebook (10%)

Due Thursday, May 3 by 4:00 pm. Late files will not be accepted. Students must bring their Clarinet Studio Notebook to class every Thursday. The hardbound 3-ring notebook will include the following:

Title page including your name and current semester

Notes on repertoire performed in studio class

must include composer, title, publisher, instrumentation, difficulty level, and personal comments on the composition

Handouts (placed in rings)

All required recital programs (placed in rings)

Biography of all repertoire composers (100 words in length) and/or composer questionnaire

Dividers between semesters/sections

Cumulative (must include information from previous semesters)

A Student demonstrates a *superior* competency in completing course and studio requirements and/or a superior comprehension of presented material. Assignments are ready at each lesson. Student attends all required lessons, studio classes and recitals.

- **B** Student demonstrates an *above-average* competency in completing course and studio requirements and/or above-average comprehension of presented material. Assignments are satisfactory. Student attends the majority of lessons, studio classes and recitals.
- C Student demonstrates an ability to *adequately* meet requirements of the course and studio requirements and/or an adequate comprehension of presented material. Assignments are not satisfactory. Student does not attend lessons, studio classes and recitals with consistency.
- **D** Effort is put toward completing requirements of the course and studio requirements, but *minimal requirements* are not met. Assignments are not done.
- **F** Student *fails* to meet acceptable standards for earning a passing grade for the course. Assignments are not done and performance is poor.
