Course Description

This course is designed to increase/help you gain knowledge and understanding of classical guitar technique through ensemble playing, concert attendance and culminating in a live performance in front of an audience or jury. The course will be divided into weekly private lessons that will allow the instructor to gauge and help your progress throughout the semester. It will also allow the students to have a clear set of practice goals in order to overcome technical and/or musical challenges.

Objectives

First time students will be able to play the guitar using a variety of right-hand patterns and techniques that will encompass notes in the first position comfortably and musically. Returning students will build on techniques learned in previous semesters and make progress towards more advanced techniques and repertoire.

Required Materials

- All students **must** have a nylon-string guitar.
- Shearer, Aaron: <u>Learning the Classic Guitar, Part 2</u>. Mel Bay Publications Inc., Pacific MO. 1990.
- Tennant, Scott: *Pumping Nylon*. Alfred Publishing (not required, but strongly recommended)
- Foot stool, or a similar guitar support like the Murato or Barnett. No exceptions.
- A small metal nail file, and 500 grit 3M sandpaper (available through www.stringsbymail.com)
- A digital recorder to record your lesson (optional, but strongly recommended)

Requirements

- 1. Attendance to your lesson is crucial to your development. You must notify me at least 24 hours in advance in order for the absence to be considered excused or made up at a later time.
- 2. All students taking applied guitar lessons are required to attend **one classical guitar concert** outside of the school. The dates for approved concerts are outlined below so that you may make timely arrangements with your place of work. Not attending the required concert because of work is inexcusable. The only accepable excuse will be due to an emergency to your direct family, or a medical emergency to your person for which

you must provide an original copy of the doctor's note. Failure to attend the required concert will result in a base grade of "C" for the semester.

- 3. ATTENDANCE TO STUDENT GUITAR RECITALS AND PROFESSIONAL GUITAR CONCERTS at SHSU IS MANDATORY
- 4. Unless instructed otherwise, the student will write a 500-word (minimum) review in proper scholarly format regarding the concert. The review is due two weeks after the performance. Student will forfeit concert report credit if report is not turned in within the given deadline. However, student can attend a different concert and submit another report within the deadline for full credit.

- 5. In order to receive an A in the course, progress and improvement must be evident from lesson to lesson. This means that you will have worked on the technical and musical challenge(s) presented in the lesson during the week and overcome said challenges by the next lesson. Some concepts and techniques will take more time to master, but this is not to be confused with negligent practice habits. An assessment will be made during the lesson as to the preparation level of the student. Lack of preparation and failure to show improvement will count negatively towards your final grade. As in any of your other classes, being unprepared for your lessons is equivalent to not turning in your assignments.
- 6. Unless told otherwise, you must dedicate **at least** one hour of engaged practice every day in order to do well in the lessons. The more you practice, the better you will be by the end of the semester. There are no shortcuts **PRACTICE IN ORDER TO DO WELL.**
- You will perform at the end of the term for either a jury or a live audience of your peers. All studies and pieces (except chamber music) must be *memorized* and everyone *must* perform in the jury/final performance. Failure to memorize the piece(s) will affect your grade.

Grading

<u>Class Preparation</u> – 35% (prepared for all lessons = 35% - you will lose percentage points for each leasson that you are unprepared for.) <u>Concert Review</u> – 25% (one review with program/ticket stub must be submitted to receive full credit) <u>Attendance</u> – 10% Final Performance / Jury - 30%
