COURSE OVERVIEW

This course introduces students to the basics of visual image production, focusing on creative visualization, video editing, lighting, on-camera performance, and studio producing/directing. Students are expected to produce original content for broadcast on Cable Channel 7. This course will also provide the foundational competencies in video production necessary to be successful in both the field and studio. Students will be exposed to experiences that will broaden their skills in basic television, media production, and short form story telling. At the completion of the course students will be required to pass a production competency exam, which will consist of two parts – written and hands on. Students unable to pass the hands on portion will be prevented from taking advanced production courses until basic production skills are mastered. Prerequisites: MCOM1332 and MCOM1371.

Course Objectives

- Understand and utilize basic concepts and techniques of shooting video in the field and in a studio setting needed by a professional working in the field
- Understand the importance of teamwork and personal responsibilities
- Conceptualize, develop, and use pre-production materials: scripts, shot sheets, etc.
- Write, shoot, and edit a public service announcement
- Write, record, edit, and produce a news story
- Write, record/shoot, edit and produce a studio production

Required Materials

- <u>Headphones:</u> Headphones are required and not provided when editing in labs and bays. Over the ear headphones are preferred but ear buds or on ear headphones will suffice.
- <u>2 SDHC Cards</u>: You will need two <u>class 10</u> SHDC cards of at least 16gb each. Lower classes may not function properly with some of the checkout equipment. No micro SD cards.

• <u>Suggested:</u> It is a good idea to have an external hard drive that you can back up all of your work on and have with you at all times. I would suggest at least 500gb, but 1 or 2tb will probably be a better bang for you buck. Having an external hard drive is NOT a requirement, but rather a suggestion and a good habit to get into.

It is also a good idea to invest in an aux extension cable. The microphones in the cell phone kits have a roughly 3 foot cable. If you do not have an extender, it can make mic'ing people up for interviews a bit tricky. You can get extension cables at any electronics store for a couple bucks.

If you don't already have one, I would also consider buying a USB cable fpr your phone so you can import files from your phone onto the computers in the lab for editing. If you have a cable that goes into a wall block, you can use that same cable and won't need to buy a new one. These are also very cheap and can be purchased almost anywhere.

ACADEMIC REQUIREMENTS AND GRADING

Assignments

You will be given handouts that detail each assignment, its requirements, and the grading breakdown and due dates for each component of the assignment. You will have separate due dates for smaller components of each project (example: scripts, shot sheets, etc). Here is a list and brief explanation of those assignments.

- *Quizzes:* There will be quizzes throughout the semester that will be based on lectures and readings. There will be no more than 5 during the semester. Some will be scheduled but a few may be given as "pop" quizzes. All material covered up to that point will be fair game for quizzes.
- *Critiques:* You will be given at home critiques to develop your eye for good and not so good production values. It will likely be you watching a TV show, interview, sporting event, movie clip, etc. with an eye on certain components, i.e.: lighting, audio, graphics/CG, edits, etc. These will correlate with the topics we will be discussing in class and will help raise your awareness of good and not so good productions. These will be assigned throughout the semester but no more than 5 total.
- Introduction Silent Video: This will be a silent video that will be completed without using any type of editing software. This means you will have to develop and use pre-production materials, and shoot everything sequentially. I will give a separate sheet that details exact parameters. The objective in this project is to learn the importance of pre-production, different types of framing, how using only images can advance your story line, and also to tell me something about yourself.
- *Public Service Announcement*: This will be a 30 second PSA. I will have a signup sheet for PSA topics. You also have the option of choosing a topic that is not listed – just run it by me first. These will also run on Cable 7 if you meet the quality criteria. So do a good job!
- News Package: This will be a 1-2 minute news package. We will talk about what these are in detail in class. The production will be different for news packages than for the PSA. I will have a list of topics that can be covered and a signup sheet. You will be able to choose on a first come first served basis. If you have your own ideas, please feel free to talk to me about using that as a topic instead. You will work in pairs for this assignment. These will also run on Cable 7 if you meet the quality criteria.
- Studio Production: This will be a 5 minute segment of a TV show. The class will be split into two groups (depending on how many people are in the class). Each group will pick what kind of TV show they would like to encapsulate, keeping in mind that it must be done in the studio. You will be graded for the overall quality of the production, and each student will be evaluated individually based off my observation, peer evaluations, and your individual role in the production.

If at the end of the semester the total points allowed is less than 1000 (i.e.: had less than 5 quizzes and/or critiques), the additional points needed will be added to the overall worth of the written final exam.

Extra credit opportunities may be available throughout the semester. However, it will not be scheduled or built in to the class structure. Therefore, extra credit may be available if and when unique circumstances present themselves.

Late Work

Exam Policy

This class will have a written and practical final exam. The written final will be given on the last day of regular classes. The practical exam will be given during the scheduled exam date. However, we will still meet on our

official exam date to give back materials/grades and finish up. We will discuss this more in detail when it gets closer.

STUDENT EXPECTATIONS

Attendance Policy

The Student Handbook provides that regular and punctual class attendance is expected of each student at Sam Houston State University and that it is expected that each faculty member will keep a record of student attendance. In this class, submitting video, audio, or graphics that were not produced/created by you, it is also considered plagiarism. Similarly, submitting projects that you did not edit or produce, will also be considered plagiarism.
