# **Course Description**

English 1301 is the basic study of English diction, sentence structure, and rhetoric with emphasis on the development of a thesis or a claim. More specifically, the course involves the study of skills and methods used in writing at the university level, with the focus on writing academic texts and incorporating documentation.

## **Course Objectives**

At the first half of a two semester sequence that constitutes first-year composition at SHSU, English 1301 is designed to introduce students to the nature of writing for academic purposes so that they will be able to develop idea through invention and express them clearly and persuasively. The course builds a solid framework for students' understanding of how reading and writing operate concurrently in academic contexts. Learning the rules and conventions of Standard American English is an essential part of learning to write competently in a university setting.
