### Course Format:

The course is designed to provide students with a thorough knowledge and practical application of the skills needed in the event of a life-threatening emergency. Skills included: Adult/Child/Infant CPR, AED, conscious & unconscious choking, splinting, wound care and other first aid skills.

### IDEA Objectives:

Essential: Learning to *apply* course material

Important: Developing specific skill, competencies, and points of view needed by professionals in the field most clearly related to this course.

### Course Content:

1. Introduction to First Aid
2. Body Systems
3. Breathing Emergencies
4. Cardiac Emergencies
5. Bleeding
6. Injuries
7. Medical Emergencies
8. Special Situations – Moving people in water, people with special needs

### Course Requirements:

1. Each student will be required to complete two (2) exams (including the final). Exam 1 (CPR/AED/Choking = 120 points), Exam 2 (First Aid = 60 Points).
2. Each student will be required to pass three (3) practical exams. The practical exams include the following skill areas: CPR (60 pts.); secondary control of bleeding (30 pts.); and Splinting (30 pts).
3. Day time class only: Each student will be required to take 11 quizzes. The exams are worth 10 points each and cannot be made up. (The lowest quiz grade will be dropped.)
4. Evening/Summer class only. Each student will be required to take 10 quizzes worth 10 points. No quiz grade will be dropped.

### **ARC CERTIFICATION REQUIREMENTS**

Students must score 80% or higher on the First Aid and the CPR/AED exam.

Students must pass CPR and SFA practical exams

Students can not miss more than **2 class days**.

Students must show a healthy attitude toward subject matter and the ARC.

*\*\*The certification through ARC is optional. If you meet the requirements and choose to get certified the fee is \$27.00. This fee is due at the end of the semester; exact change or check made payable to SHSU. \*\**

**Expectations:**

ATTENDANCE POLICY: (Semester). If you show up later than roll has been called or passed around the class room it will count as an unexcused absence.

1. In order to get certified you can miss no more than 2 class days
2. *If class meets once a week, you can miss no more than 1 class day to get certified*
3. More than 3 absences will affect your grade in the following manner:
  - a. 4 unexcused absences = reduction of final letter grade by one letter
  - b. 5 unexcused absences = reduction of final letter grade by two letters
  - c. 6 unexcused absences = reduction of final letter grade by three letters
  - d. 7 unexcused absences = failure
4. *There is a certification fee of \$27.00, made payable to SHSU, if you meet the certification requirements. Optional NOT required.*

**(Summer or Evening class)**

1. *In order to get certified you can miss no more than 1 class day*
2. More than 1 absence will affect your grade in the following manner:
  - a. 2 unexcused absences = reduction of final letter grade by one letter
  - b. 3 unexcused absences = reduction of final letter grade by two letters
  - c. 4 unexcused absences = reduction of final letter grade by three letters
  - d. 5 unexcused absences = failure

**STUDENT GUIDELINES:**

1. Wear appropriate clothing. We will be on the floor most days so be prepared to be on your knees, etc.
2. Refrain from chewing gum/eating in class while working with the mannequins
3. Remove lipstick or lip-gloss before practicing on mannequins
4. Bring textbook to class everyday
5. Wear hair away from face when practicing on mannequins
6. Turn off cell phones at all times.
7. Show up before roll has been called or roll sheet passed around the class room. If the student is not present when roll is called, it will count as an unexcused absence.
8. Show up before the quiz has been handed out. If quiz has already been handed out, the student will not be allowed to make up the quiz.
9. Assist in set-up and remove of equipment. If student does not show respect and is helpful the teacher has the right to determine the consequences including failure of the class.

**Academic Honesty:** Academic honesty is expected in all work. Ignorance is not an excuse. Penalties will include 0 points for the assignment or exam and loss of any extra credit opportunities. First instance will result in a 0 on the assignment and the incident being noted. Second instance will result in failing the class, and both incidents will be reported. Remember that self-plagiarism (using something you did) is also considered academic dishonesty.

The subject of academic honesty is addressed in paragraph 5.3, Chapter VI, of the *Rules and Regulations*, Board of Regents, The Texas State University System, and Sam Houston State University *Student Guidelines* published by the Office of Student Life to wit:

5.3 Academic Honesty. The University expects all students to engage in all academic pursuits in a manner that is above reproach. Students are expected to maintain complete honesty and integrity in the academic experiences both in and out of the classroom. Any student found guilty of

dishonesty in any phase of academic work will be subject to disciplinary action.

5.31 The University and its official representatives, acting in accordance with Subsection 5.32, may initiate disciplinary proceedings against a student accused of any form of academic dishonesty including, but not limited to, cheating, plagiarism, collusion, and the abuse of resource materials.

"Cheating" includes the following and similar actions:

(1) Copying from another student's test paper, laboratory report, other report, or computer files, data listings, and/or programs.

(2) Using, during a test, materials not authorized by the person giving the test.

(3) Collaborating, without authorization, with another student during an examination or in preparing academic work.

(4) Knowingly, and without authorization, using, buying, selling, stealing, transporting, soliciting, copying, or possessing, in whole or in part, the contents of an unadministered test.

(5) Substituting for another student, permitting any other person, or otherwise assisting any other person to substitute for oneself or for another student in the taking of an examination or test or the preparation of academic work to be submitted for academic credit.

(6) Bribing another person to obtain an unadministered test or information about an unadministered test.

(7) Purchasing, or otherwise acquiring and submitting as one's own work any research paper or other writing assignment prepared by an individual or firm. This section does not apply to the typing of the rough and/or final versions of an assignment by a professional typist.

5.32 "Plagiarism" means the appropriation and the unacknowledged incorporation of another's work or idea into one's own work offered for credit.

5.33 "Collusion" means the unauthorized collaboration with another person in preparing work offered for credit.

5.34 "Abuse of resource materials" means the mutilation, destruction, concealment, theft or alteration of materials provided to assist students in the mastery of course materials.

5.35 "Academic work" means the preparation of an essay, dissertation, thesis, report, problem, assignment, or other project that the student submits as a course requirement or for a grade.

"Self-plagiarism represents a significant problem in academia as it serves to undermine the learning process and outcomes that are a key feature of each course that is offered as a part of a student's curriculum. As a result, the Department of Health and Kinesiology has a strict policy in place to prevent self-plagiarism in the classroom. Self-plagiarism is defined as the submission of any type of assignment that contains content that is recycled from other assignments or a prior publication that one submits for course credit in another course."
