Course Description

This course provides students with a comprehensive survey of the components, organization, and management of the US health care system. Topics of the course include the historical perspectives, structure, operations, economic indicators, and current/future directions of the US health care delivery

RATIONALE: The course is designed to introduce you to the field of healthcare with a wide survey of its core components and functions. Additionally, you will become familiar with the core health system missions of access, cost and quality.

You will gain the necessary cognitive information through readings, media, discussion, and assignments. Additionally, the course will allow you opportunity to analyze and discuss prominent societal issues. Because this is an online course, it is important that you keep up with assignment due dates and submit your work on time to demonstrate your learning progress.

3) Content Knowledge and Skills—Overview of Health Systems (Objective 4)

Learning Objective Description

By completion of the BS in Public Health, all graduates will be able to describe the fundamental characteristics and organizational structures of the U.S. health system as well as the differences in systems in other countries.

a. Content Knowledge and Skills—U.S. Health Systems (Indicator a)

Indicator Description

HLTH 3355 Healthcare delivery in the U.S. unit exam, assessed with a traditional 100-point scale rubric (Superior >90, Proficient 70-90, Developing<70) measuring proficiency in describing the structure, payments systems, regulation, and major challenges of the current U.S. healthcare system;

Criterion Description

Using the three-level rubric, 100% of students will be at least Proficient and 50% of the students will be Superior.

READING QUIZZES

There are 11 quizzes including 10 chapter quizzes and 1 syllabus quiz. One will be dropped to arrive at 20% of total final grade. I will manually calculate and drop the lowest grade from the calculation of final grade (<u>resulting in actual grade may be lower than the Blackboard displayed total grade until final grade is manually assigned</u>). Quizzes within a module are available until module due date noted on the calendar. Module due dates are on Saturdays. Please check Blackboard and consult the course calendar for dates. **Single attempt, No late submissions and No make-ups**.

DISCUSSIONS

There are 4 blackboard discussions that each student must participate in. 40% of total grade. The first discussion is to introduce yourselves and the rest are special topics related to the US healthcare system and are located in modules 1 to 3. Please see the course calendar for module due dates and check the discussion assignments for detailed instructions on how to complete the assignment. **No make-ups and no late submission allowed.** Late submission will result in a zero grade.

GROUP PAPER

You have the opportunity to form your own group of 4 students until the deadline (check the calendar file on Blackboard). After the deadline, I will assign each of you to a group consisting of 4 students (3, if there is no one left to form a group of 4). Your name will appear on a **group membership list** under the Group Paper module. There you will find your group members and their contacting information. Your responsibility as a group is to write a 10 page paper on the comparison of international health systems to the US system. Reference materials related to international health systems is attached in the assignment folder and will appear when available (check calendar for availability date). Additional requirements will be provided along with the reference materials. Health administration is a writing intensive profession. Therefore, please keep in mind that grammar counts significantly toward one's grade. **No make-ups and no late submission allowed.**

This paper accounts for 40% of the course grade. There are two (2) parts to the grade. 1) Paper grade. 2) Peer evaluation grade. The peer evaluation will be on a scale of 0-5 points. Your grade will be formed from multiplying paper grade and the transformed peer evaluation grade.

To calculate your grade, take your paper grade and multiply by the transformed factor %. For example, if your paper scored the full 40 points, but your peer evaluation is 4 (or 90%), take 40 x 90%, and your grade is equal to 36 points.

Group Communication Techniques: The learning objective of a group paper is to gain communication skills required in a true work environment. In real life situations, you will often be assigned to work on group projects. The trick to a successful project is to keep communicating and DOCUMENT your communication attempts. Email trails are very good records. If your group decides to drop a member because of lack of communication from this member, you need to document your MULTIPLE attempts at trying to reach this member before dropping this person. If you document and seek permission from the professor prior to dropping the person, you will be cleared of responsibilities. This is a technique that will save your careers in the future.

Additional ASSIGNMENT CRITERIA

For the group paper assignment, you must use APA 6th edition style to cite all sources for in-text and citation and bibliographies. In addition, use double space, 12 point font, Times New Roman, and one inch margins.

BONUS or PENALTY

The submission of the syllabus signature assignment will net a 1% bonus if submitted by due date. On the other hand, the non-submission of the signature by the end of the semester will result in a **5% course grade deduction penalty** assessed at the end of the course towards the total grade.

Plagiarism and other assignment need-to-knows:

- □ If an assignment seems unclear, it is YOUR responsibility to talk to the instructor early.
- □ If you desire academic accommodation for a documented disability, please see the section on Americans with Disabilities Act (ADA) ASAP.
- □ *Plagiarism* is a big word that simply means using someone else's work or writing without giving credit. If you copy a paragraph, sentence or even phrase from someone else's work,

you must place quotes around what you have copied and cite the author. If you borrow an idea from someone else, but don't quote them exactly, you don't need to add the quotes, but you still must cite the author. When citing an author, use either the APA style (**Brown**, **2014**) or the AMA style (superscript number¹) immediately after the statement. Then, in the Endnotes give the entire reference: *1. Brown*, *S* (2014). Best article. Journal of Cool Stuff; 4(2), p.3-7. This is your warning; if you borrow without giving credit you will get zero points for the parts borrowed. If you are working on an assignment that requires all your own work (or an exam), you should not be citing other authors anyway.

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose.
