General Information

No textbook is required for this course. Readings on selected topics will be provided throughout the semester.

Course Description

Course Objectives: This course has two primary objectives. The first is to discuss current practice in clinical psychology, with an emphasis on the integration of empirical research into clinical practice. The second objective is to provide a space for group supervision and consultation regarding clinical work at each of your practicum placements.

The topics covered in the class will be discussed at the beginning of the semester. Students will play an active role in determining the clinical topics of interest and a course schedule will be determined collaboratively.

Specific Learning Outcomes: By the end of this course, you should:

- 1. Be able to meaningfully apply current literature to your own clinical practice.
- 3. Understand the importance of consultation in clinical settings.
- 4. Be able to meaningfully summarize clinical conceptualizations and clinical progress in a way that is useful to colleagues (either for consultation or learning demonstration).

The learning outcomes described above will be assessed through an informal case presentation and class participation.

Format of the Course: Each week, a chosen topic relevant to clinical practice will be discussed. It is expected that students in this course will have completed the assigned reading for the week so that we may have a meaningful discussion for the first half of the course. The second hour of the class will be spent discussing your current clinical work in your outside setting. At the end of the semester, each student will present a brief informal case conceptualization from his/her current clinical placement. Please see additional details below.

Course Requirements

Class Attendance: Class attendance is important in this course. Ongoing learning of the psychotherapeutic or assessment process, supervision, and consultation are important in your progression as clinicians. Therefore, class attendance is expected for each student.

Assigned Readings: Readings will be assigned for many weeks. In order to generate meaningful discussion of each topic, it is important that you complete the assigned readings.

Class Participation: All students must participate! Although all students will be asked about their current clinical work each week, it is also important that each of you actively participates in the discussion section of the first half of each class.

Case Conceptualization: Towards the end of the semester, we will begin case conceptualizations. This is not to be a formal presentation (i.e., no written conceptualization is needed). This is designed to be an opportunity to practice succinctly discussing a clinical case, including relevant background information, presenting problems, the strength of the therapeutic relationship, therapeutic techniques used, progress in treatment, and future therapeutic goals (if applicable).

Grades will be determined based on your participation in class, performance on your case conceptualization assignments, and evaluations from your primary clinical placement sites.

Professional Behavior

Laptops: As this is intended to be a discussion-based course, I ask that you refrain from using your laptops. If there is a time in which you would like to take notes of the materials being discussed, you may use your laptop, as long as this is not at the expense of class discussion.

As graduate students, I expect that each of you will exhibit professional behavior in this regard. While I understand the many competing responsibilities, I ask that you please refrain from checking email or surfing the web while in class.
