COURSE DESCRIPTION

HIST 1301 is the first half of the U.S. history survey at Sam Houston State University. This class offers students an introductory overview of the chief social, cultural, and political developments in North America between 1492 and 1876.

The historical aspect of this course focuses on:

- 1. The impact of the meeting of European, Native American & African cultures during the age of Exploration.
- 2. The establishment of the English and European colonial systems in North America.
- 3. The development of the American Revolution and early Republic.
- 4. The expansion, fracture, and reconstruction of the United States in the nineteenth century.

LEARNING & SKILL OBJECTIVES

- 1. **Factual Knowledge** Students will gain factual knowledge about United States History.
- 2. **Critical Thinking** Students will learn to analyze and critically evaluate ideas, arguments, and points of view.
- 3. **Communications Skills** Students will hone their ability to communicate with others, particularly in the written format.
- 4. **Personal Responsibility** Students will learn personal responsibility by being responsible for class assignments, note taking, reading, and ensuring they are prepared for lectures and exams.
- 5. **Social Responsibility** By better understanding history, students will be able to reevaluate themselves in order to better understand their social responsibilities in a modern context.

ASSIGNMENTS AND GRADING

Exams: There will be four exams over the course of the class. Each exam features an objective section (multiple choice) and a writing section. The exams (as well as the final) are worth 150 points each. If a student is absent on an exam day, an email with excuse for absence is to be sent to the professor by end of that day. If the professor excuses the absence, the student will schedule a time to take a make-up exam.

Writing Assignments: Over the course of the semester each student will complete 3 writing assignments. These assignments are due at the start of class on the specified day. If the student is absent on the due date, the student must send a copy of the paper via email that day. Any papers submitted after the due date will be accepted for half credit.

Participation: Participation covers a student's activity in class. In-class assignments and discussions contribute to a student's participation grade.

ATTENDANCE POLICY

Mobile Phones: All mobile devices will be silenced during class. Ringtones are distracting to your classmates as well as the instructor. If you forget to silence your phone and it goes off in class, the instructor reserves the right to dismiss you from the class and count that day as an absence for the student.

Recording Devices: No recording devices are allowed in the class room; video, audio, or otherwise.

STUDENT ABSENCES ON RELIGIOUS HOLY DAYS POLICY:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: "a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20...." A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form notifying the student of a reasonable timeframe in which the missed assignments and/or examinations are to be completed.
