Course Description: Pricing and output policies of firms, resource pricing, and distribution under condition of perfect competition, monopoly, oligopoly, and monopolistic competition Prerequisite: ECO 2300 or 2301.

NOTE: If you are a business major, I presume that you have successfully completed BANA 2372, as per the undergraduate catalog.

Learning Objectives: Upon completion of this course, the student will have learned

- 1. How consumers make decisions regarding what they buy.
- 2. How producers make decisions regarding what they sell and how they make it.
- 3. How markets work to distribute goods and services from producers to consumers.
- 4. What happens when markets don't work the way they're supposed to.
- **Text:** Pindyck and Rubinfeld, *Microeconomics* (8th most recent, but just about any edition)

Other Resources: Tutoring is available; hours and room TBA.

Grading: Your grade will be determined by your performance on a series of weekly quizzes. There will be 12 scheduled quizzes, each worth 100 points. You will be allowed to drop your two lowest quiz scores, however, so your grade will be based on a 1000 point total:

- A: 900 points (90% of 1000)
- B: 800 points (80% of 1000)
- C: 700 points (70% of 1000)
- D: 600 points (60% of 1000)
- F: Below 600 points.

Note: There is no "rounding". 799 points, for example, is still a "C".

If you are satisfied with your grade after the completion of the regular semester, you do not have to take the final. If however you wish to improve your grade, you may take a comprehensive final as a replacement for your lowest <u>three</u> quizzes (not counting the two dropped). The final will therefore be worth a maximum of 300 points. As an example, suppose Sammy has quiz scores 60, 70, 90, 75, 65, 85, 80, 50, 0, 60, 80, 70. If he drops his low two (0 and 50), his point total is 785, a "C". Now suppose he takes the final and scores 270, replacing his low four quizzes of 60, 60, and 65. His new point total is 870, so he now has a "B". If you score less than your low three quizzes on the final, the final will not count.

Attendance: I will take attendance at the beginning of each class period at least until I learn your name. The quizzes will serve as a good reason to come to class.

Student Absences on Religious Holy Days Policy

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). This request must be made in the first fifteen days of the semester or the first seven days of a summer session in which the absence(s) will occur. The instructor will complete a form notifying the student of a reasonable time during which the missed assignments and/or examinations are to be completed.
