#### Awards/Honors:

Award presented by the Alexander von Humboldt Foundation. The award letter, dated August 20, 2007 begins with the following statement: "In acknowledgement of your scientific achievements in your specific academic field and in recognition of your contribution towards scientific co-corporation with German colleagues I have the pleasure to invite you on behalf of the Alexander von Humboldt Foundation for a renewed academic stay in Germany for a period of three months" (signed by Dr. Steffen Mehlich). This award resulted from an anonymous nomination by either a member of the Alexander von Humboldt administration or board of directors, or by a German scholar. The total amount of the award is 11,050 Euros (\$16,100 current exchange rate) for living and travel expenses (plus a supplemental award for support of a spouse.

Award presented by the Alexander von Humboldt Foundation. The award letter, dated May 10, 2001, begins with the following statement (translated from German): "... in recognition of your scientific work in your field of specialization and your contributions to cooperative scientific work with German colleagues it gives me special pleasure, in the name of the Board of Governors of the Alexander von Humboldt Foundation, to award you a ... scientific research stipendium ..." (signed by Dr. Gisela Janetzke). The total amount of the award is DM 17,000, including DM 5,400 per month living expenses for three months in Germany, DM 10,000 for travel expenses, and DM 800 for travel within Germany for research purposes. The researcher has the discretion to divide the award and use it for several research related trips to Germany. No stipulations were made as to the specific nature of the research or where the research is to be conducted in Germany.

The letter from the national offices stated that the Wall of Honor "includes persons who have made a significant contribution to victims' rights and victim awareness in the United States." The letter goes on to state that, to the knowledge of the national office, I was the first professor in the United States to establish a regular course in Victimology. December, 2000.
