All students must complete Campus Prevention Training prior to registration, while employees must complete SHSU Sexual Misconduct Employee Training with 30 days of their hire date.

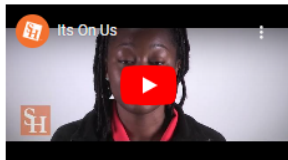
