History of the Program

Sam Houston State University (SHSU), located in Huntsville, Texas, was created by the Texas Legislature in 1879 as Sam Houston Normal Institute dedicated to the education and training of teachers for the public schools. The baccalaureate degree was first awarded in 1919. In 1923, the institution's name was changed to Sam Houston State Teachers College. Two years later, the college was admitted to membership in the Southern Association of Colleges and Schools (SACS) as an accredited institution of higher learning. A graduate degree was authorized in 1936, and following World War II, an increase in students and faculty as well as a wide range of faculty research activities provided the impetus for the emergence of a multi-purpose institution. In 1965, the institution became Sam Houston State College, and then in 1969, Sam Houston State University. Currently, SHSU is organized into eight colleges: Business Administration, Criminal Justice, Education, Health Sciences, Fine Arts & Mass Communication, Humanities and Social Sciences, Science & Engineering Technology, and Osteopathic Medicine (founded in 2019). The University and its faculty are recognized regionally, nationally, and internationally.

The Home Economics Program originated in 1909 with a primary concern for the domestic arts. In 1945, a graduate degree was approved. By the 1970s, it had become a department and had expanded its curriculum to include emphasis in four additional areas of specialization: fashion merchandising, food science and nutrition, foodservice management, and interior design. The name of the department was changed to Consumer Services, Fashion, and Design in 1988, and then to Family and Consumer Sciences (FACS) in 1996. Originally part of the College of Education, in 2004 the department was moved to the newly created College of Humanities and Social Sciences. During August of 2014, the Texas Board of Regents voted that all degrees and programs in the Department of Family and Consumer Sciences, including the **Bachelor of Science in Food Science and Nutrition** (the single track for the undergraduate degree; offered at the Main Campus in Huntsville and on-site only) and the Master of Science in Dietetics, be moved to the recently formed College of Health Sciences. The approval was finalized in October of 2014. The current DPD Director was a part of the planning for the transition from the College of Humanities and Social Sciences to the College of Health Sciences.

More recently, SHSU has expanded its reach by offering programs partially or fully online, at the Woodlands Center (an additional campus located in The Woodlands, Texas, 35 miles from SHSU Main Campus), and at various other sites. While students may elect to take some of the core courses through online delivery, as well as FACS 2362 Nutrition (the introductory nutrition course for the BS in Food Science and Nutrition), the remaining courses in the curriculum must be taken in a face-to-face setting.

History of Accreditation

In 1994, the Food Science and Nutrition Program was an approved Didactic Program in Dietetics (DPD) by the Commission on Accreditation of Dietetic Education (CADE). During 2001, both the DPD and the Dietetic Internship (DI) were granted developmental accreditation by CADE. In 2006, the DPD was grated accreditation by CADE. Since 2006, the DPD has adhered to the Standards of Accreditation, including the 2012 accreditation standards and now the 2017 standards required for reaccreditation.

Significant quality improvements have been made since the initial accreditation of 2001 through additions to faculty lines, staff, resources, and funding support based the President and her cabinet's strategic plans and trends (I, 2, 3, 4, 5, 6, 7, 8. 9. 10) as well as the projections predicted by the U.S. Bureau of Labor Statistics and the Global Health Workforce Alliance (11, 12, 13, 14, 15). The hiring of new faculty has allowed the program to provide systematic offerings of courses consistent with the four-year plan of study. We have been able to minimize the need for having two levels of students in the same course because course offerings are more frequent. New campus relationships to support experiential learning activities have been established with the Student Health Center, Recreational Center/Wellness, and the Inter-Professional Education (IPE) working group.

The Department of Family and Consumer Sciences was relocated from the College of Humanities and Social Sciences during October of 2014. The attached Organizational Charts for both the University and the Department of Family and Consumer Sciences are attached which shows the location of the Undergraduate Food Science and Nutrition Program (DPD) in line with this department (Exhibits 19,20). The DPD Director was a part of the committee which worked on the relocation of the Department of Family and Consumers Sciences to the College of Health Sciences during the spring of 2014.
