Educational & Experience Requirement: Terminal degree in a discipline represented at Sam Houston State University (SHSU). Demonstrated successful experience in academic administration; evidence of scholarly and professional achievement that will merit a tenured faculty appointment at the rank of associate/professor in a department within Sam Houston State University (SHSU). Experience in administration, budget management, personnel management, and strategic planning is expected. A combination of education, experience, and training that would produce the required knowledge and abilities could be considered.

Nature & Purpose of Position: Assumes delegated responsibility for graduate studies; leads university-wide efforts on community engagement for the Office of the Provost including oversight of The Woodlands Center location, the Center for Community Engagement, and the Center for Law, Engagement, and Politics; administrative leadership for academic program reviews of graduate programs as required by THECB; assists with university-wide accreditation efforts; and other related administrative functions as defined by the Provost and Sr. Vice President for Academic Affairs.

Supervision Given & Received: Works under minimum direction. Reports to the Provost and the Sr. Vice President for Academic Affairs. Directly supervises support staff personnel.

Primary Responsibilities: Serves as the senior academic and administrative officer of graduate programs at Sam Houston State University (SHSU). Provides administrative oversight for graduate programs and initiatives across campus, serves as a resource in the development of graduate courses, programs, and degrees, and administers selected graduate scholarship programs. Maintains a presence in regional and national professional associations for graduate studies, supports faculty and academic deans in online and distance education graduate programs, and exercises fiscal responsibility for The Graduate School including graduate student travel and research funds. Participates in academic policy development through membership on the Council of Academic Deans, provides leadership in developing short and long-range plans for graduate education, and communicates activities with reporting agencies. Provides strategic leadership for utilization and operations of The Woodlands Center location. Coordinates a university-wide strategy for connecting the university with the local communities (notable Huntsville, Conroe, and The Woodlands); Develops and implements strategy for bringing campus together with local and regional partners in order to advance the mission of the university; Performs other related duties as assigned.

Other Specifications: Outstanding scholar in a field with demonstrated experience as a visionary leader in graduate education and community engagement. Experience and understanding of the diversity of academic disciplines; proven skills in academic administration, resource management, and innovative programming; and demonstrated evidence of strong communication and interpersonal skills with an effective track record of working collaboratively with administrators, faculty, staff, and students, and demonstrated ability to communicate clearly and effectively with all constituencies.

Must value and encourage a diverse range of scholarship and the creative process, have the ability to coordinate multiple programs and initiatives and cultivate an environment of collaboration, demonstrate a record of increasing level of leadership responsibility, and a notable record of accomplishment in strategic planning, grantsmanship and/or fundraising, and community and external audience outreach. A commitment to support online graduate education, an understanding of the role of international students in graduate education, a goal of enhancing the experience of a diverse student body, and a goal of establishing strategic partnerships between the university and local communities. Contacts include the President, vice presidents, associate vice presidents, deans, chairs, faculty, staff, Texas Higher Education Coordinating Board staff, The Texas State University System staff, counterparts at other educational institutions, and federal and state officials as required.
