Criterion Description:

All BS in Health Sciences students must complete the internship with a passing grade of "A" in all four Public Health content areas: A) knowledge/skill application, B) interdisciplinary exposure, C) mentoring, and D) professional preparation and networking.

Findings Description:

96% of students did this.
