#### **Closing Summary**

The enrollment for the RN to BSN program has continued to increase with the joint admission students from Alvin College, Blinn College, and Lone Star College programs. We did add Temple College this past year but as of yet have not been successful in recruiting students to our program. Our main influx of students in the joint admission programs has come from Blinn College. This past summer we did have to open the second section of one course to accommodate the student load. We are still limiting the courses to 25 students per class but we did overload Informatics (May mini) over our 25 limits.

The program is fortunate to have maintained the same faculty without any changes. One faculty member did pick up a course that she had not taught prior and did well with the changes. In Spring 2021 we did trial 7A and 7B courses in Rural Health and Informatics. Students seem to like the 7.5-week courses and looking a curriculum changes and moving the program to the 7.5-week model this coming year. We will maintain the 10-week courses for summer.

This past year we continue to struggle with COVID-19 which has affected our students. As faculty, we have noticed more late assignments because of the RN's workload at their facilities related to COVID.

Please see the attachment of 2020-2021 Assessment Plan RN to BSN Information which will show the goal that was met and the ones that were not met. We will continue to monitor all the goals for the upcoming year with some modifications which are listed below.

We are looking at making changes in some of our benchmark objectives in Legal/Ethics NURS 4381 - Code of Ethics Assignment (title change only) will continue with the same benchmark. NURS 4382 Informatics title change on Social Media Assignment will continue the same benchmark. NURS 3340 Older Adult will remove the Older Adult Clinical Journal but will replace with a Pharmacology Exercise. Will continue with the Older Adult on Patient Centered Communication Discussion forum. NURS 4384 Genetics will continue with the Genetics Protein Synthesis discussion forum but will remove the patterns of Inheritance discussion forum. Will continue with the Genetics Pedigree assignment. NURS 4030 Community will separate the Windshield Survey and Infographic to make two separate assignments to be monitored. NURS 4060 Leadership no changes. NURS 4372 Capstone no changes. NURS 3370 Role Transition no changes. NURS 3360 Research no changes. NURS 4384 Rural Health will remove the EBP resources discussion board and will replace with a Telehealth assignment.

# **Update of Progress to the Previous Cycle's PCI:**

2021-2022

This past year (2021-2022) we have seen a slight decrease in student enrollment in the RN to BSN program. The causes could be attributed to financial issues as other RN to BSN programs in the area are slightly lower tuition costs and with the economic strain currently in our nation and state has put a limit on educational desires. Also, the continuation of COVID pandemic which has put a strain on the full-time RNs with increase in work schedules and family concerns has limited time for educational pursuits.

We continue to have joint admission students from Alvin College, Blinn College, Lone Star College, and Temple College. We still need to improve our recruiting events to promote our Temple connection, but it has been limited due to COVID. Still pending adding Angelina College and are waiting for the Associate Dean in College of Health Science to complete the transaction. Also, need to follow up with Wharton College and possibly have director of school of nursing discuss with their director to set up a meeting. In the past they had shown interest but did not complete meeting set-up.

Still limit number of online students to 25 per course. Summer 2021 courses – Rural Health had two sections because of need. One course had 23 students and the other had 19 students. Older Adult course was over by one student. Role Transition was over by one student. This was the first summer to offer Nursing Research and we had 25 enrolled with 23 completing the course. These were mainly joint admission students taking this course.

Faculty continues to remain constancy. We did have one faculty member resign in May 2022 due to family issues, but another faculty member has agreed to pick-up that course (Role Transition) for fall, so did not add any new faculty members at this time. The faculty has worked on course redesign to move to the 7.5-week semester which started in Spring 2022. They have worked with Instructional designers for Blackboard to make our courses more standardize for ease of the students and for faculty to transition between courses if needed. We have also worked with marketing committee to promote new curriculum changes to help entice prospect students to complete the RN to BSN program sooner or still work at their own pace. The summer courses will remain at 10-week semester with the influx of joint admission students. The faculty continue to struggle with late assignments in all courses and feel it is related to work schedules with the pandemic.
