RELATED ITEM LEVEL 2

Indicator, Criterion, and Findings: Knowledge and Skills Indicator Description:

(1) Indicator type: Rubric. Students will complete the Online Learning assessment during ISDT 6351. The assessment requires students to create three online modules that may be used to prepare instructors to deliver online courses. Students choose each module's topic based on their interest. Students build the modules in a learning management system of their choice, and each module must contain at least one content item, one multimedia item, one interactive item, and one assessment using a Web 2.0 tool.

(2) Indicator type: Rubric. Students will complete the Online Teaching assessment during ISDT6351. This assignment is built upon the Online Learning assessment. The assessment requiresstudents to apply evidence-based practices to develop pedagogical activities in those three modules.

Criterion Description:

(1) At least 80% of students will earn Excellent on the section of Online Technologies of the rubric.

(2) At least 80% of students will earn Excellent on the section of Pedagogy of the rubric.

Findings Description:

Both criteria are in ISDT 6351, which was offered in Fall 2023. 100% of the students earned

Excellent on the sections of (a) Online Technologies and (b) Pedagogy of the rubric.
