The following actions will be taken and data monitored in order to assess activities:

- Recruitment: Efforts continue to increase enrollment to the program. The rollout of the new social
 media and webpage are being completed. With the increased requirements of enrollment and the
 continued attacks on school librarianship, it has been difficult to increase enrollment. However, a new
 one-year scholarship for MLS and certificate-seeking students will remove at least a financial barrier
 for first-semester students who do not have other means of support for the first semester.
- Texas Education Agency has changed requirements for practicum observations and hours. The
 program will establish a new protocol to meet these new requirements and will pilot it beginning Fall
 2024.

• Dispositions-- professors monitor dispositions within the program every class, every semester.

- TExES-- for the next year, professors will implement specific microlearnings for the Candidates to assist in their success on the certification examination.
