PROFESSIONAL SUMMARY

An attorney by trade and a conflict resolution professional by passion, I have provided high-level legal advice, always coupled with business decisions in mind to individuals and companies. Believing that a significant amount of time, energy, and resources are depleted because of unproductive methods of dealing with disputes, I have focused on conflict resolution skills. Currently, I support students by helping them understand their legal rights and obligations, ways to handle conflict maturely, and improve civic responsibility.

My peers have selected me for leadership positions in the professional conflict resolution community, including (1) President of the Association for Conflict Resolution, Dallas Chapter; (2) Secretary and Chair of the ADR Section of the Dallas Bar Association; (3) Member of the Board of Directors and President of the Texas Association of Mediators; and (4) Council Member for the State Bar of Texas' Alternative Dispute Resolution Section. My speaking engagements include professional ADR groups, legal associations, students, and business professionals.

Since joining SHSU, our office has experienced tremendous growth. Consultations have increased by 51%. Retention and academic focus improved for our students by double-digits, also.

In all years, students noted that they were satisfied with our services at 90% or higher, with 99% of students saying they would recommend our office to others.

We also developed "Conflict Resolution Month" where, each October, the university community explores the causes of conflict and ways to resolve it. Our office developed programming where nationally and internationally recognized experts educated SHSU's students, faculty, and staff in Huntsville and our center in The Woodlands.

The Western Region of the United States Student Legal Services Association awarded our office with the 2015 Jim Aldridge Special Project Award of Excellence
