Update to Previous Cycle's Plan for Continuous Improvement

Previous Cycle's Plan For Continuous Improvement (Do Not Modify):

The Department will require additional organizational capacity to further develop this degree plan. During the prior assessment cycle, a designated advisor left her position. This reduced some of the department's ability to respond to direct questions from students about the degree plan and further reduced the assistance with program oversight. In the upcoming year, the Department will seek to develop a Director of Undergraduate Programs who will help facilitate the program's development. Further, a faculty committee will be tasked with an informal program review of the degree plan to conclude with recommendations for the program.

Update of Progress to the Previous Cycle's PCI:

A Director of Undergraduate Programs has been named. In this new role, she has been tasked with helping to facilitate the program's development and general oversight of the program.

We struggled this year with transitioning faculty and instructors who are primarily responsible for CRIJ 4398. Over the next year it will be important to convene such faculty and instructors as part of a series of meetings to improve program assessment, as well as share feedback on our ongoing efforts.

Additionally, methods regarding assessment of student knowledge of victim studies concepts, etc. must be addressed. Faculty and instructor "buy in" will be needed.

Closing Summary:

For the 2016-2017 academic year, continued emphasis will be placed on strengthening the VS BA/BS program. There has been a lot of change administratively that has impacted the progress of the VS undergraduate program. The department has a new chair and as a result, the responsibilities of the undergraduate program director have shifted. In the upcoming year, the Chair and Undergraduate Program Director will clarify who is responsible for overseeing the program's development.

The program continues to struggle with appointing a faculty or instructor who is primarily responsible for the program's capstone course (CRIJ 4398). The necessity of this course will be discussed by the Chair and Undergraduate Program Director.
