The Director, Assistant Director, and CVI-affiliated faculty and students submitted 7 manuscripts to peer reviewed outlets, of which 3 have been published and the remaining are in various stages of revision for resubmission.

CVI will continue to track the number and placement of peer-reviewed publications produced from CVI-funded projects and will assess the quality of publication outlets. ## **Results Description:**

The Director and Assistant Director have been working on an ongoing large federal grant awarded through Office of Violence Against Women for \$393,000 to evaluate Houston Police Department's mandatory sexual and family violence training and focus on victim-centered and trauma-informed responses to victims.

Additionally, CVI-affiliated faculty have applied for three grants and two of them have been funded for a total of \$249,000 in award funds.

#### **KPI Description:**

The Crime Victims' Institute will publish at minimum, four technical reports on scientific research addressing victimization-related topics for dissemination to victims' service providers, state legislators, and key constituents.

During the 2016-2017 reporting period, CVI produced 4 technical reports on topics that included intimate partner violence, campus sexual assault, sexual minority survivors, and safety planning.

The Director and CVI-affiliated faculty attended and presented research at two conferences for the 2016-2017 period:

- 2. Texas Victim Services Association Bi-Annual Meeting

#### **Action Description:**

Depending on budget and staff availability, CVI will attend, exhibit, and or present research at a minimum of one professional conference/workshop tailored to victim service providers and criminal justice practitioners to further circulate technical reports and present translational research to interested audiences and relevant constituents.

#### G4 Publish reviews of the current state of knowledge related to victimization

#### **Performance Objective Description:**

The Crime Victims' Institute will disseminate a special series focusing on one form of victimization, with issues devoted to prevalence, system response, aftermath, prevention, and resources for best practices in Texas.

#### **G4** Special issue series

#### **KPI Description:**

The Crime Victims' Institute will publish and disseminate one special issue series (consisting of multiple reports) on a timely victimization topic and will address prevalence, response, aftermath, prevention, and best-practices.

## **Results Description:**

CVI finalized the last issues of the special series on Human Trafficking and began a special series on Campus Sexual Assault.

#### **G4: Publish Special Topics Report Series**

#### **Action Description:**

The Crime Victims' Institute will disseminate a special series focusing on one form of victimization, with issues devoted to prevalence, system response, aftermath, prevention, and resources for best practices in Texas. This will include, at minimum, four issues within the series for the next cycle.

## **Update to Previous Cycle's Plan for Continuous Improvement**

#### Previous Cycle's Plan For Continuous Improvement (Do Not Modify):

CVI anticipates hiring at least one new staff person during the next cycle. This will allow the Institute to return to levels of activity as indicated in our goals and objectives. New staff will attend relevant trainings related to victimization and victim services, as well as trainings to assist in completing CVI activities, including newsletters, reports, and grant applications. The plan for next cycle is to continue quarterly newsletters and to develop a new research report series addressing campus sexual assault. CVI staff will also manage a large, federal grant and consider additional opportunities for grant funding.

#### **Update of Progress to the Previous Cycle's PCI:**

CVI was successful in meeting its goals during the 2016-2017 cycle. CVI had four main goals addressed below:

\*Building the reputation of CVI - It is critical to the mission of CVI that the personnel associated with the Institute are knowledgeable about victimization and victim services and that the importance of CVI's work is communicated to relevant audiences. We continue to excel in training and outreach. All staff have completed more than the minimum training requirement by participating in additional webinars on relevant topics. CVI continues to be actively involved in outreach by partnering with other groups across campus and within the victim services field on awareness-raising activities and events. We regularly share this information through the CVI newsletter with various audiences, including university personnel, the CVI Advisory Board, the Texas legislature, and victim services professionals. CVI will continue to improve our knowledge through additional training opportunities, to engage the university and broader community in outreach efforts, and to share relevant knowledge and highlight our activities through the newsletter.

\*Connection with SHSU's academic programs - With a focus on translational research and outreach, CVI prioritizes connection with academic programs within the College of Criminal Justice. The Institute also funded two PhD students for summer fellowships to complete research projects related to victimization. Pending available budget, we plan to continue providing opportunities for students to be engaged in the research conducted by CVI and to conduct their own research relevant to CVI's mission. The Institute also provides funding for graduate students to attend and present their research at both national academic conferences and local victim service conferences.

\*Excellence in research - CVI's mission is to conduct research on issues relevant to victimization, victim services, and prevention. We continue to be successful in fostering peer-reviewed publications, conference presentations, and translational reports derived from the numerous projects that are ongoing. During the 2016-17 cycle, CVI-affiliated faculty submitted three grant proposals--two of which were funded, meeting that particular goal. We also have continued to manage and work on a large, federally funded grant project during the 2016-17 cycle.

\*Translate research into practice - Part of CVI's mission in conducting research on victimization includes the dissemination of best practices for practitioners, victim service providers, criminal justice agencies, and other constituents.

CVI's activities remained somewhat restricted during this cycle as a result of reductions in personnel. We did not disseminate as many research reports as we typically do, and we did not submit as many grant applications as planned. We anticipate returning to full form during the next assessment cycle.

## Plan for 2017-2018

## **Closing Summary:**

CVI used funds in a fiscally responsible way by paying 17% of a staff person's time to address all budget, purchasing, and financial operations for the Institute at the end of FY 2016-2017.

The planned hiring of a dedicated CVI staff person was delayed due to a university-wide hiring freeze. The plan for the next cycle is to hire one additional staff member who will attend relevant trainings related to victimization and victim services, as well as trainings to assist in completing CVI activities, including newsletters, reports, and grant applications.

CVI will continue disseminating quarterly newsletters that provide updates on current projects and relevant Institute information, and will develop a new research report series focusing on Hate Crimes.

CVI staff will continue to manage a large, federal grant and apply for a substantial state grant to assess gaps in victim service provisions in Texas. CVI will consider additional opportunities for grant funding.
